BACKGROUND

- 1 On November 28, 2011, Qwest Corporation d/b/a CenturyLink (Company) filed a request with the Washington Utilities and Transportation Commission (Commission) to overturn the Number Pooling Administrator’s decision to withhold numbering resources and direct the Number Pooling Administrator to provide one block of 1,000 numbers in the 360 Numbering Plan Area (NPA), Vancouver rate center. The Company also requests the Number Pooling Administrator reserve the remaining nine blocks within the same code to be available for future needs of this specific customer of the Company. The request is being made to meet the requirements for a customer’s need for 1,000 sequential numbers to support consolidations and moves from other out-of-area service locations to the Vancouver campus. These numbers will be used within six months. Approximately 200 number resources will be returned when the Bellevue location closes down and approximately 900 numbers will be returned from many other rate centers including Bellingham and Longview. The customer is a non-profit business using the numbers for its employees.

- 2 Telephone companies commonly hold and manage a reasonable inventory of telephone numbers in the areas where they provide service. When more numbers are needed by a company, it may request them from the Number Pooling Administrator. The Number Pooling Administrator withholds telephone numbers if the company’s inventory is sufficient for the next six months and there is a shortage of numbers in the affected area code.

- 3 The Number Pooling Administrator’s Web site reports an inventory of eight blocks of 1,000 numbers in the Vancouver rate center, and the North American Numbering Plan Administrator’s (NANPA’s) Web site reports that the 360 NPA is forecasted to exhaust in the 1st quarter of 2017. The Federal Communications Commission, in its Third Report and Order, FCC 01-362, CC Docket 96-98 and 99-200, has delegated authority to

the Commission to direct NANPA to release blocks of numbers for extenuating circumstances that do not meet NANPA's existing criteria. Qwest Corporation d/b/a CenturyLink provided the Commission with a detailed inventory of number resources and proof of utilization in the rate center. Qwest Corporation d/b/a CenturyLink will adhere to the requirement of reviewing number resources and comply with the requirements of the NANPA and the Pooling Administrator regarding the return of unused numbers.

- 4 The Federal Communications Commission (FCC) issued an order establishing a “safety valve” allowing companies that do not meet the utilization threshold in a given rate center to obtain additional numbering resources apart from the general waiver process.¹ Specifically, the FCC granted to state Commissions the authority to direct the Number Pooling Administrator to release a block of numbers to a company to satisfy a specific customer request that cannot be met with the company's current inventory provided the company documents the customer request and submits current proof of utilization.

FINDINGS AND CONCLUSIONS

- 5 (1) The Washington Utilities and Transportation Commission is an agency of the State of Washington vested by statute with the authority to regulate the rates, rules, regulations, practices, accounts, securities, transfers of property and affiliated interests of public service companies, including telecommunications companies. *RCW 80.01.040, RCW 80.04, RCW 80.08, RCW 80.12, RCW 80.16 and RCW 80.36.*
- 6 (2) Qwest Corporation d/b/a CenturyLink is a telecommunications company and a public service company subject to Commission jurisdiction.
- 7 (3) The Telecommunications Act of 1996 (the Act) allows the FCC to establish rules to implement the Act and delegate authority to state Commissions.
- 8 (4) The FCC has created a “safety valve” mechanism within the framework of number resource management and delegated to the Commission authority to grant requests by companies that receive a specific customer request for numbering resources that exceeds their available inventory. The FCC has also given states

some flexibility to direct the Number Pooling Administrator to assign additional numbering resources to companies that have demonstrated a verifiable need for additional numbering resources.

- 9 (5) The Commission has jurisdiction over this matter pursuant to RCW 80.36.610, which authorizes the Commission to take actions necessary to implement the Act.
- 10 (6) Normally, additional numbering resources are granted only when existing resources are forecasted to exhaust within six months.²
- 11 (7) The Number Pooling Administrator's Web site reports an inventory of eight blocks of 1,000 numbers in the Vancouver rate center, and the NANPA's Web site reports that the 360 NPA is forecasted to exhaust in the 1st quarter of 2017.
- 12 (8) The request is being made to meet the requirements for a customer's need for 1,000 sequential numbers to support consolidations and moves from other out-of-area service locations to the Vancouver campus. These numbers will be used within six months. Approximately 200 number resources will be returned when the Bellevue location closes down and approximately 900 numbers will be returned from many other rate centers including Bellingham and Longview. The customer is a non-profit business using the numbers for its employees.
- 13 (9) This matter came before the Commission at its regularly scheduled meeting on December 15, 2011.
- 14 (10) The Commission has reviewed Qwest Corporation d/b/a CenturyLink's request and concludes that the Company has demonstrated a legitimate need for sequential numbers to meet a customer requirement. Accordingly, the Commission will order the Number Pooling Administrator to release one block of 1,000 numbers in the Vancouver rate center to Qwest Corporation d/b/a CenturyLink and reserve the remaining blocks within the same code to be available for future needs of this specific customer of the Qwest Corporation d/b/a CenturyLink.

ORDER

THE COMMISSION ORDERS:

- 15 (1) The Number Pooling Administrator to release one block of 1,000 numbers, specifically in the 360 NPA, Vancouver rate center to Qwest Corporation d/b/a CenturyLink and reserve the remaining blocks within the same code to be available for future needs by this specific customer of the Qwest Corporation d/b/a CenturyLink.
- 16 (2) The Commission retains jurisdiction over this matter to take such future actions as may be appropriate.

The Commissioners, having determined this Order to be consistent with the public interest, directed the Secretary to enter this Order.
