ORDER GRANTING EXTENSION OF
TIME TO COMPLETE PROJECT AND
SUBMIT REQUEST FOR
REIMBURSEMENT

BACKGROUND

- 1 On January 27, 2017, the Snohomish County Public Works (County or Petitioner) filed with the Washington Utilities and Transportation Commission (Commission), a petition seeking approval to install active warning devices at a railroad-highway grade crossing, identified as USDOT 084683A, on 48th Ave NW in Snohomish county. The Petitioner further requested the Commission authorize an expenditure of \$262,693 from the Grade Crossing Protective Fund (GCPF) to pay for a portion of the upgrades.
- 2 On March 8, 2017, the Commission issued an Order approving the request for disbursement from the GCPF and the petition to install active warning devices at the 48th Ave NW crossing. The Order required the County to complete the project and submit the associated request for reimbursement by December 31, 2017.
- 3 On November 15, 2017, the County submitted a request for an extension of time to complete the project and submit the request for reimbursement. The County states that additional time is required in order to finalize the construction agreement with BNSF Railway Company and to allow sufficient time for construction of the project. Staff recommends that the Commission extend the project completion date until December 31, 2018, to provide additional time for all aspects of the project to be completed within the GCPF project completion deadline.

FINDINGS AND CONCLUSIONS

- 4 (1) After reviewing the County's request, and giving due consideration to all relevant matters and for good cause shown, the Commission grants the extension of time to December 31, 2018.

ORDER

THE COMMISSION ORDERS:

- 5 The request of Snohomish County Public Works for an extension of time to complete the crossing safety upgrades is granted, subject to the following conditions:
- (1) Expenditure from the Grade Crossing Protective Fund must not exceed \$262,693.
 - (2) The work for which the Grade Crossing Protective Fund disbursement was approved must conform to the project description specified in the application.
 - (3) The County must sign and return the attached revised project agreement by December 15, 2017.
 - (4) Payment will be made upon presentation of claim for reimbursement and verification by Commission Staff that the work has been satisfactorily completed.
 - (5) The project must be completed and the associated request for reimbursement from the Grade Crossing Protective Fund must be filed with the Commission no later than December 31, 2018.

The Secretary of the Commission has delegated authority over this matter pursuant to Order 01 in Docket A-151775. The Secretary finds this Order to be consistent with the public interest.
