NEW MANDATORY WATER USE RESTRICTIONS

August 14, 2015

Hello Talcott Ridge Water System Customers:

As you know H&R Waterworks, Inc. monitors water usage closely, especially during warmer weather. Our goal is to allow full utilization of water in an efficient manner. Earlier in July we had mandated each homeowner to revise their irrigation schedule and this mandatory action was partially met and the system has not experienced storage depletion.

However, our area is experiencing a drought as has been declared by the Governor. Correspondingly, Talcott Ridge water consumption in July exceeded June usage by 12.3%, increasing from an average daily consumption of 1,386 gallons per home per day in June to 1,556 gallons per home per day in July. The July average daily use exceeded average daily use during May by 1,027 gallons per day or 220%!!!

Talcott Ridge homeowners are justifiably proud of their homes and yards, however, action must be taken to reduce consumption. The company is monitoring all water consumption on a weekly and monthly basis.

Our reduction schedule request made of you on July 31st was not sufficient. To help insure that sufficient water remains available for the balance of this year, **the company is imposing, immediately, a limit on outdoor irrigation** which will be tracked by individual service.

MANDATORY IRRIGATION SCHEDULE:

<u>Irrigation is limited to two days a week for all customers; residential and irrigation. Customers whose address ends in odd number may water two days a week; Saturday and Wednesday.</u>

The same restriction for customers whose address ends in an even number, limit is two days a week; Sunday and Thursday.

Our goal is to be sure that all irrigation controllers are set to a timeframe which allows all sprinkling and watering to be completed between 10 p.m. and before 4 a.m. or between 10 a.m. and 3 p.m. ON THE TWO DAYS A WEEK WHICH ARE AUTHORIZED FOR YOU.

<u>Please reset/check your controllers to establish that your irrigation is completed before 4 am on each day you are authorized to irrigate.</u>

For your part, we also request that you please confirm by email to customercare@thewaterco.net that you have made necessary timing modifications by no later than August 20, 2015. We expect to be able to lift this limitation by October 15, 2015.

For our part, we believe that each customer with an irrigation system installed will confirm their hours of operation for their controllers. Doing so will allow all of us to accomplish this goal.

This ACTION is mandatory. Your compliance is appreciated by your neighbors and the company.


