TO ALL PARTIES:

On March 14, 2019, the Washington Utilities and Transportation Commission (Commission) entered and served Order 01, Authorizing Transfer (Order 01) in Docket TC-190087. Order 01 inadvertently omitted language from Appendix A. This erratum notes and corrects that error by inserting into Appendix A the following language:

**BETWEEN:** Whidbey Island and King County Convention Center, CenturyLink Stadium or Safeco Field for sporting shows and events, boat shows and events, home shows and events, RV shows and events, and golf shows and events; **AND**

**BETWEEN:** Whidbey Island and Sporting events, concerts, casinos, wineries, and performing arts theaters in Washington.

**BETWEEN:** Oak Harbor and hotels and motels within a 1-mile radius and hotels and motels within a 1-mile radius of the SeaTac International Airport.

**CLOSED DOOR SERVICE: BETWEEN** Deception Pass and SeaTac International Airport and **BETWEEN** the Clinton Ferry and SeaTac International Airport.

**SCHEDULED PASSENGER SERVICE** by reservation only:

**AIRPORTER PASSENGER SERVICE BETWEEN:** Whidbey Island and Paine Field Airport.

**CLOSED DOOR SERVICE BETWEEN:** Deception Pass and Paine Field and **BETWEEN** the Clinton Ferry and Paine Field.

**NOTE:** Nothing in this certificate authorizes transportation between SeaTac International Airport and hotels and motels within a 1-mile radius of SeaTac.
