TO ALL PARTIES:

On April 8, 2019, the CenturyLink companies<sup>1</sup> filed with the Washington Utilities and Transportation Commission (Commission) revisions to their currently effective tariffs to discontinue private switch/automatic location identification services, currently described in the Emergency 9-1-1 service sections of the CenturyLink Companies' tariffs.

The Commission consolidated these dockets and suspended operation of the tariffs on April 25, 2019, and convened a prehearing conference at Olympia, Washington on May 13, 2019. The parties agreed on a preliminary procedural schedule at the prehearing conference that included a June 7, 2019, settlement conference followed by a status conference that was later scheduled for July 30, 2019. The Commission adopted the parties' proposed preliminary procedural schedule, which was attached to Order 03 in the consolidated dockets.

On July 30, 2019, the Commission convened a status conference during which all of the parties to the proceeding presented a joint proposed procedural schedule for the resolution of

the consolidated dockets. The Commission adopts the parties' proposed modifications to the procedural schedule, as reflected in Appendix A to this Notice.
