GRANTING EXTENSION OF TIME TO COMPLETE PROJECT AND SUBMIT REQUEST FOR REIMBURSEMENT

## BACKGROUND

- I On October 16, 2019, Olympia & Belmore Railroad, Inc., (Olympia & Belmore Railroad or Applicant) filed with the Washington Utilities and Transportation Commission (Commission) an application requesting a disbursement of \$1,851.98 from the Grade Crossing Protective Fund (GCPF) to pay for a project related to installing and replacing missing or defective warning signs, along with the required sign posts, hardware, and reflective striping, at 12 public and private railroad crossings located on its line in Thurston County. The Applicant filed an amended application on November 7, 2019, and filed an updated materials list on January 27, 2020. The total amount requested from the GCPF was \$1,764.13.
- 2 On February 6, 2020, the Commission issued an Order approving the request for disbursement from the GCPF. The Order required the Applicant to complete the project and submit the associated request for reimbursement by June 30, 2020.
- 3 On October 13, 2020, the Applicant submitted a request for an extension of time to April 30, 2021, to complete the project and submit the request for reimbursement. The Applicant explained that, due to an internal communication failure, staff responsible for executing the project were not aware of the grant approval and timeline for completion.
- 4 Staff recommends that the Commission extend the project completion date until April 30, 2021, to provide additional time for the project to be completed within the GCPF project completion deadline, which will ensure reimbursement documents are submitted before the current biennium ends on June 30, 2021.

## DISCUSSION

5 As authorized by RCW 81.53, the GCPF provides funding for projects that reduce accident frequency and severity at public and private railroad crossings, or reduce pedestrian trespassing and motorist injuries and deaths on railroad rights-of-way at places other than crossings. We find that the proposed improvements will increase crossing safety, and that extending the deadline is appropriate to ensure project completion.

# FINDINGS AND CONCLUSIONS

- 6 (1) The Commission is an agency of the state of Washington having authority under RCW 81.53.281 to approve and administer disbursements from the GCPF for rail safety projects.
- 7 (2) On October 16, 2019, Olympia & Belmore Railroad submitted an application for funding from the GCPF to pay for improvements at 12 passive crossings on its line in Olympia.
- 8 (3) On February 6, 2020, the Commission approved Olympia & Belmore Railroad's application for funding.
- 9 (4) On October 13, 2020, the Applicant requested an extension of the project period and deadline for applying for reimbursement to April 30, 2021.
- (5) Commission Staff investigated the Applicant's request for extension and recommends that it be granted. Granting the extension helps ensure timely completion of the project and submission of reimbursement documents.
- (6) After reviewing Olympia & Belmore Railroad's request for extension, and giving due consideration to all relevant matters and for good cause shown, the Commission finds that granting additional time to complete this project and apply for reimbursement is appropriate and in the public interest, and grants the extension of time to April 30, 2021.

# THE COMMISSION ORDERS:

12 The terms of Order 01 remain in full force and effect with the following change:
