Good This is Docket TV-200820, which is a formal 7 morning. 8 complaint for penalties against Super Friends Moving, LLC, doing business as Super Friends Moving. 9 The 10 complaint alleges that Super Friends operated without a permit in violation of RCW 81.80.075(1) and the cease 11 12 and desist order entered against Supper Friends by the Commission in Order 2 in Docket TV-170206. 13 14 My name is Samantha Doyle, and I'm the administrative law judge presiding over today's 15 prehearing conference. 16 Today is Thursday, October 22nd, 2020, and 17 18 the time is approximately 9:37. 19 This prehearing conference is going to be a 20 chance for the parties to discuss a procedural schedule. 21 Let's take short appearances, and Commission 22 Staff? 23 MR. ROBERSON: Good morning, Judge Doyle. My name is Jeff Roberson, Assistant Attorney General. 24 Ι 25 represent Staff. With me at counsel table are Staff's

ROBERSON: Judge Doyle, at this point, 4 5 Staff would move to admit pages 7 and 8 of the attachments as Exhibit JHJ-2. 6 JUDGE DOYLE: And Exhibit J-JH [sic] 2 is 7 8 admitted into the record. Thank you. 9 (Exhibit JHJ-2 admitted.) BY MR. ROBERSON: 10 Ms. Hawkins-Jones, did Super Friends have a 11 Ο. 12 permit at the time it was advertising or providing these 13 quotes? 14 No, it did not. Α. 15 Did it subsequently obtain a permit? Ο. 16 No, it has not. Α. 17 Okay. But we're clear that it did not have a Ο. permit at this -- at this time, in early August? 18 19 Α. Correct. Okay. At this point, Staff 20 MR. ROBERSON: has no further question, Judge Doyle. 21 22 JUDGE DOYLE: Thank you. And with that, I will grant your motion and memorialize it in the order. 23 24 I'd also like to note on Public Counsel's 25 comment that based on the company's poor compliance

GAFKEN: Judge Doyle, I was wondering if 8 I could ask a few questions of the witness as well, because there's a few points that I wanted to make sure 9 were clear on the record. 10 11 JUDGE DOYLE: Absolutely. Apologies for not 12 giving you the opportunity. Public Counsel, go ahead. 13 14 EXAMINATION BY MS. GAFKEN: 15 16 Good morning, Ms. Hawkins-Jones. 0. 17 Good morning. Α. So the Commission had ordered the company to 18 Ο. 19 cease and desist and that means that it -- it was not 20 allowed to operate and that includes advertisements and providing quotes, correct? 21 22 Α. Correct. 23 0. And that also means that they're -- they're not 24 allowed to advertise in -- in any manner, correct? 25 Α. Correct.

My understanding is that Super Friends has a 1 Q. 2 position that it assumed that it would be permitted at 3 the time of the move that you were requesting; is that 4 your understanding as well? 5 Α. Yes, that is my understanding. 6 Okay. But even though they may have had this 0. 7 assumption that it would be permitted at the time that the move would occur, it was still a violation of the 8 cease and desist order by advertising, correct? 9 10 Α. Correct. And it was also still a violation of the cease 11 Ο. 12 and desist order when it provided you a quote for -- for the move, correct? 13 Correct. 14 Α. And this is not the first violation by Super 15 0. 16 Friends in -- in terms of operating while not permitted 17 and providing quotes for moves while not permitted, 18 correct? 19 Α. Correct. 20 MS. GAFKEN: Okay. Thank you. I don't have 21 any further questions, Judge Doyle. 22 JUDGE DOYLE: Thank you, Ms. Gafken. 23 Are there any other issues that we should 24 discuss before adjourning today? 25 MS. GAFKEN: I'll just bring up one more --
