RATE INCREASE NOTICE FOR MASON COUNTY ROLL-OFF SERVICE

Dear Customer:

January 26, 2021

Mason County Garbage Co., Inc. has filed a request for a rate increase with the Washington Utilities and Transportation Commission (WUTC). The last general rate increase was approved by the WUTC April 1, 2013. Since that time, the Company has experienced higher costs for employee wages, benefits, fuel, and truck equipment and has purchased additional capital assets.

If approved by the WUTC, the proposed rates will become effective March 1, 2021.
