Dear Commercial Customer,

This is to notify you of a proposed change to commercial service rates for solid waste collection in Yakima County where Basin Disposal of Yakima, LLC operates. Should the Washington Utilities and Transportation Commission (Commission) approve the proposal, the customers will experience a rate increase throughout all classes of service as follows:

As you may be aware, it has been nearly thirteen years since our last general rate case. In that time, Basin Disposal of Yakima, LLC experienced significant increases in costs that are essential to delivering services, including labor, insurance, fuel, maintenance expenses, along with federal and state employment taxes. In addition, the company continues to acquire new assets to ensure it can deliver the safest, most efficient, and reliable service possible. If approved, the proposed rates will become effective on June 1, 2023.

The proposed rate increase for our Commercial services ranges from approximately 7.26% to 60.62% and not all offered services are listed above. If you have questions about the proposed rate increase, you may contact the company at (509)547-2476.

The Commission has the authority to set final rates that may be either lower or higher than the company's request, depending on the results of its investigation.
