On April 11, 1974, Cascade Natural Gas Corporation (Cascade), a Washington corporation, filed an application to amend its present Certificate of Public Convenience and Necessity to Operate a Gas Plant for Hire, No. 4, amended, to include additional areas in Adams, Benton, Kitsap, Skagit and Walla Walla Counties. (Appendices A-2, A-4, A-11, A-13 and A-16, amended.)

Cascade is presently certificated for and is now providing gas service in the above-designated counties. The additional areas requested are contiguous to the aforesaid presently certificated areas.

FINDINGS OF FACT

1. Cascade Natural Gas Corporation, a Washington corporation, operates a gas plant for hire in this state and is subject to the jurisdiction of this Commission.
2. Cascade has heretofore been issued a Certificate of Public Convenience and Necessity to Operate a Gas Plant for Hire, No. 4, amended.
3. Cascade has filed an application to amend its Certificate of Public Convenience and Necessity, No. 4, amended, to include additional areas contiguous to its presently certificated areas in Adams, Benton, Kitsap, Skagit and Walla Walla Counties.
4. The operation of a gas plant for hire in the additional areas requested is or will be required by the public convenience and necessity.
5. The Certificate of Public Convenience and Necessity to Operate a Gas Plant for Hire, No. 4, amended, presently held by Cascade Natural Gas Corporation, should be further amended to include the additional areas applied for herein.

O R D E R

1. IT IS HEREBY ORDERED That the application of Cascade Natural Gas Corporation to amend its Certificate of Public Convenience and Necessity to Operate a Gas Plant for Hire, No. 4, amended, to include additional areas contiguous to its presently certificated areas in Adams, Benton, Kitsap, Skagit and Walla Walla Counties is hereby approved and said Certificate shall be amended in accordance with attached Appendices A-2, A-4, A-11, A-13 and A-16, amended, which, by this reference, are made a part hereof as though fully set forth herein.

2. IT IS FURTHER ORDERED That the Certificate of Public Convenience and Necessity to Operate a Gas Plant for Hire, No. 4, amended, issued pursuant to Order Paragraph No. 1, above, supersedes and cancels the Certificate of Public Convenience and Necessity to Operate a Gas Plant for Hire, No. 4, as amended and issued to Cascade Natural Gas Corporation on January 20, 1972, in Cause No. U-10001. Said Certificate of January 20, 1972, shall be forthwith returned to this Commission.

3. IT IS FURTHER ORDERED That the Certificate issued pursuant to Order Paragraph No. 1, above, is subject to the terms, conditions, and provisions of the Orders in Cause Nos. U-8841, U-8843, U-8937, U-9047, U-9052, U-9194, U-9238, U-9239, U-9253, U-9263, U-9264, U-9360, U-9388, U-9394 and U-9407, U-9450, U-9467, U-9469, U-9596, U-9600, U-9708, U-9759, U-9807, U-9808, U-9819, U-9790, U-9822, U-9860, U-9864, U-9872, U-9873 and U-10001.

4. IT IS FURTHER ORDERED That jurisdiction over this Cause is retained to effectuate the provisions of this order.

APPENDIX A-13 AMENDED - LEGAL DESCRIPTION - WALLA WALLA, COLLEGE
PLACE AND VICINITY - WALLA WALLA COUNTY

All of the incorporated area comprising the City of Walla Walla and College Place and additional portions of Walla Walla County lying within the area described as follows:

Beginning at a point where the east line of Sec. 14, T. 6 N., R. 36 E.W.M. intersects the boundary line between Oregon and Washington; thence in a westerly direction along the northern boundary of the state of Oregon to a point where said boundary intersects the west line of Sec. 16, T. 6 N., R. 35 E.W.M.; thence north along the west line of Secs. 16, 9 and 4, T. 6 N., R. 35 E.W.M. and Secs. 33, 28, 21, 16 and 9 of T. 7 N., R. 35 E.W.M. to the northwest corner of Sec. 9, T. 7 N., R. 35 E.W.M.; thence east along the north line of Secs. 9, 10, 11 and 12, T. 7 N., R. 35 E.W.M., and Secs. 7, 8, 9, 10, 11 and 12 of T. 7 N., R. 36 E.W.M. to the northeast corner of Sec. 12, T. 7 N., R. 36 E.W.M.; thence south along the east line of Secs. 12 and 13, T. 7 N., R. 36 E.W.M. to the southeast corner of Sec. 13, T. 7 N., R. 36 E.W.M.; thence west along the south line of said Sec. 13 to the east line of Sec. 23, T. 7 N., R. 36 E.W.M.; thence south along the east line of Secs. 23, 26 and 35 of T. 7 N., R. 36 E.W.M., and Secs. 2, 11 and 14 of T. 6 N., R. 35 E.W.M., to the point of beginning.

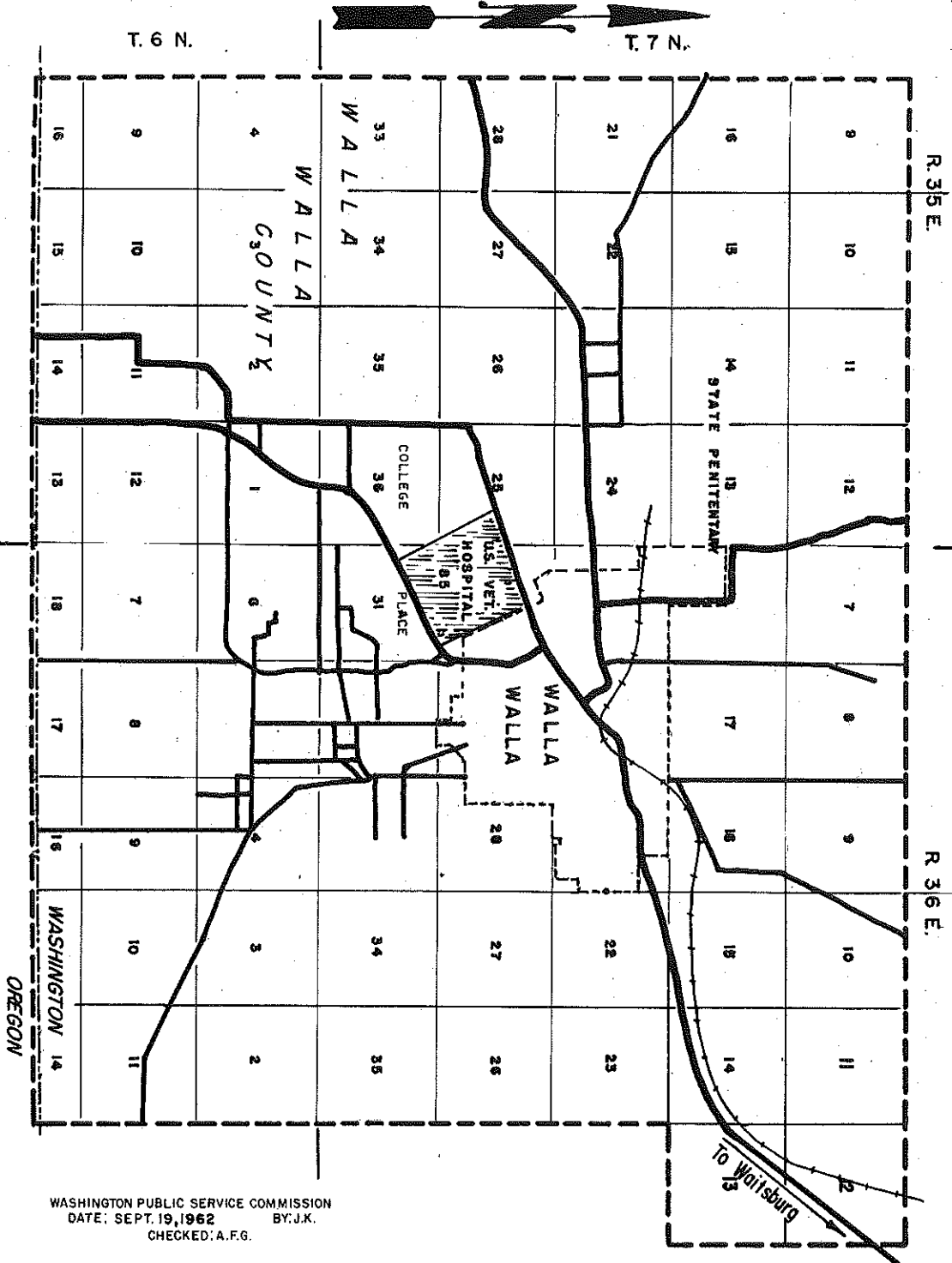
