On February 11, 2004, in Docket No. TG-040221, Harold LeMay Enterprises, Inc.,
filed an application (No. GA-079251) for extension of authority under Certificate
No. G-98, standing in the name of Harold LeMay Enterprises, Inc., d/b/a City

Sanitary Co., EGH Disposal, Harbor Disposal Co., Joe's Refuse Service, Lakewood Refuse Service, Pacific Disposal, Pierce County Refuse, Rural Garbage Service, White Pass Garbage Co., and Butlers Cove Refuse, for authority to provide solid waste collection service consisting of biomedical waste in King, Pacific, Kitsap, Wahkiakum, Cowlitz, Clark, and Skamania Counties. Notice of the Application was published in the Commission's weekly Docket of February 23, 2004.

- On February 13, 2004, in Docket No. TG-040248, Kleen Environmental Technologies, Inc., filed an application (GA-079254) for a certificate of public convenience and necessity to operate motor vehicles in furnishing solid waste collection service consisting of biomedical waste in the state of Washington. Notice of the Application was published in the Commission's weekly Docket of February 23, 2004. On March 31, 2004, Kleen Environmental Technologies, Inc. amended its application to exclude Whatcom and Skagit Counties and those parts of Snohomish County not already served by Rubatino Refuse Removal under Certificate No. G-58.
- The Commission has jurisdiction over this matter under Title 81 RCW, which authorizes it to regulate persons seeking to furnish solid waste collection services under chapters 81.77 RCW and 480-70 WAC. The issues in the proceedings include 1) whether the existing solid waste collection companies serving the territories sought in the applications of Harold LeMay Enterprises, Inc. and Kleen Environmental Technologies, Inc. will not provide service to the satisfaction of the Commission, and 2) whether the issuance of an amended certificate to Harold LeMay Enterprises, Inc. and a certificate to Kleen Environmental Technologies, Inc., for the services they propose is necessary and is otherwise consistent with the public interest.

In as much as the foregoing matters involve related principles of law and overlapping authority, it is appropriate that they be consolidated for hearing and determination pursuant to WAC 480-07-320 and WAC 480-70-111.

ORDER OF CONSOLIDATION

5 THE COMMISSION ORDERS That these matters are consolidated for purposes of hearing and determination. The Commission reserves the right to hold such separate hearings and to enter separate orders in the individual dockets as it may deem appropriate.

The parties are further advised that the sanction provisions of WAC 480-07-450 are specifically invoked.
