- On June 9, 2005, Pac-West Telecomm, Inc. (Pac-West), filed with the Commission a petition for enforcement of interconnection agreement with Qwest Corporation. One June 16, 2005, Qwest filed an answer and counterclaim to the petition. The petition states that Qwest refuses to compensate Pac-West for all local and ISP-bound traffic, including calls from Qwest customers to an ISP that obtains foreign exchange service from Pac-West. The Commission has jurisdiction over this matter pursuant to Title 80 RCW, having legal authority to regulate the rates, services, and practices of telecommunications companies providing service within the state of Washington.
