In Georgia Pacific's response dated January 27, 2012, identified by the Washington Utilities and Transportation Commission (WUTC) as the January 31, 2012 response, Georgia Pacific requested confidentiality for the three submissions Georgia Pacific has made to the WUTC, in connection with the above referenced matter. Assistant Attorney General Don Trotter contacted Georgia Pacific and its counsel to clarify the request for confidentiality. This letter is in response to those discussions and the agreed upon resolution with your office.

With this letter, we are resubmitting our cover letters and certain documents for which Georgia Pacific is claiming confidentiality, pursuant to WAC § 480-07-160. Specifically, we respectfully request that the WUTC file the enclosed redacted versions in the public docket as replacements for the following documents that were previously submitted: (1) Attachments 37, 39 and 40 to the October 21, 2011 submittal from Georgia Pacific; (2) Attachment 6 to the January 18, 2012 response from Georgia Pacific, and (3) page 12 of Attachment 10 to the January 31, 2012 response from Georgia Pacific. Note that because the January 18, 2012 response from Georgia Pacific was attached in its entirety as Attachment 10 to the company's January 31, 2012 response, Attachment 6 and Attachment 10 are the same document. Finally, the resubmitted cover letters contain the requested confidentiality statement denoting which attachments are being designated as confidential to protect individual privacy, pursuant to WAC 480-07-160.
