Dear Mr. Danner:

PacifiCorp, d.b.a. Pacific Power & Light Company (PacifiCorp or Company), submits the following in accordance with the Washington Utilities and Transportation Commission's (Commission) Notice of Receipt of Petition for Declaratory Order and Opportunity to Submit Statements of Fact and Law (Notice) issued in Docket U-111663 on September 20, 2011. PacifiCorp is commenting to express support for the arguments set forth in the petition filed by Puget Sound Energy, Inc. (PSE). PacifiCorp believes that the outcome of this proceeding could be precedential with respect to future application of apprenticeship labor credits toward compliance with Washington's Energy Independence Act, Chapter 19.285 RCW (Act). Further, although PacifiCorp has not applied for certification to use apprentice labor in the construction of renewable generation facilities, it may desire to do so in the future. As such, PacifiCorp shares the concerns expressed by PSE with respect to certain parties' limited interpretation of the Act. Therefore, PacifiCorp recommends that the Commission issue a declaratory order in this proceeding and grant the relief requested by PSE.
