Dear Mr. Danner:

On June 1, 2012, Puget Sound Energy, Avista Utilities, and PacifiCorp filed reports related to both the renewable and conservation components of the Energy Independence Act (EIA). Due to limited resources, Public Counsel has focused its review on the conservation component of the reports, which were filed pursuant to RCW 19.285.070 and WAC 480-109-040. Public Counsel will file detailed comments on the conservation issues. Public Counsel has not reviewed the reports as they pertain to the renewable component of the EIA, and we do not take a position with regard to reporting or compliance.¹

It is important to note that the Commission determination in these renewable dockets does not constitute a finding of prudence with respect to any renewable resource. The prudence of renewable resources for ratemaking purposes is determined by the Commission in the context of a general rate case for the applicable company at the time the Company seeks to recover the costs in rates. Public Counsel accordingly reserves the right to engage in a prudence review of
