21	1. WAC 480-123-100(1)(a): The Company is a local exchange company as defined in WAC

23	480-120-021 that serves less than forty th	lousand access lines within the state.

- WAC 480-123-100(1)(b): The Company is an incumbent local exchange carrier as defined in 47 U.S.C. Sec. 251(h).
- 3. WAC 480-123-100(1)(c): The Company offers basic residential and business exchange telecommunications services as set forth in WAC 480-120-021 and RCW 80.36.630.

4. WAC 480-123-100(1)(d): The Company's rates for residential local exchange service, plus mandatory extended area service charges, are no lower than the local urban rate floor established by the Commission as the benchmark rate based on the Federal Communications Commission's national local urban rate floor pursuant to 47 C.F.R. Sec. 54.318 in effect on the date of this Petition.

5. WAC 480-123-100(1)(e): The Company has been designated by the Commission as an eligible telecommunications carrier for purposes of receiving federal universal services support pursuant to 47 C.F.R. Part 54 Subpart D - Universal Service Support for High Cost Areas with respect to the service area for which the Company is seeking Program support.

WAC 480-123-110(1)(e)(viii): A statement under penalty of perjury from a Company officer with personal knowledge and responsibility certifying that the Company complies with state and federal accounting, cost allocation, and cost adjustment rules pertaining to incumbent local exchange companies is attached as Exhibit 8.
- 12. WAC 480-123-110(1)(f): A complete copy of the FCC Form 481 filed by the Company or on its behalf with the Federal Communications Commission for the calendar year preceding the current year has already been filed with the Commission. See the Company's filing in Docket No. UT-170011filed on or about June 30th 2017.

13. WAC 480-123-110(1)(g): The number of residential local exchange access lines served by the Company as of December 31, 2016, was 1460 all of which were within the geographic area for which the Company is seeking support. The number of residential local exchange

access lines served by the Company as of December 31, 2015, was 1303, all of which were within the geographic area for which the Company is seeking support.

The number of business local exchange access lines served by the Company as of December 31, 2016, was 339, all of which were within the geographic area for which the Company is seeking support. The number of business local exchange access lines served by the Company as of December 31, 2015, was 262, all of which were within the geographic area for which the Company is seeking support.

The monthly recurring rate charged by the Company for residential local exchange access service on December 31, 2016, was \$18.00. The monthly recurring rate charged by the Company for residential local exchange access service on December 31, 2015, was \$16.00. The rate charged by the Company for single line business local exchange access service on December 31, 2016, was \$18.00. The rate charged by the Company for single line business local exchange access service on December 31, 2015, was \$16.00. (The Company has other business local exchange service rates, but the Company understands that WAC 480-

123-110(1)(g) is requesting the single line business local exchange access service rate.)

14. WAC 480-123-110(1)(h): The requested statement is attached as Exhibit 9.

15. The amount on Line 4, labeled 2011 ROR Carrier Base Period Revenue, of the CAF ICC Data collection Report for the period 7/1/2017 - 6/30/2018 is \$885,921 and has not changed from the last filing. **[ALTERNATIVE:** If there has been a change, provide the old and new amounts and explain the reason for the change.]
