Carmen Ceron-Garza declares:

1. I am over the age of 18 years of age and am competent to be a witness in this proceeding. I am making this Declaration based upon my own knowledge and information.
2. I am the sole governor of Garza Wine Tours LLC (UBI 603-411-384).
3. My husband, Armando Garza, Jr., is the sole governor of A Plus Taxi LLC which is a sister company of Garza Wine Tours LLC.
4. When we created Garza Wine Tours LLC in 2014, our intention was that all tours would be operated through A Plus Taxi LLC. Garza Wine Tours LLC consisted of a website and phone number that potential clients could call to schedule a tour. Garza Wine Tours LLC never conducted any tours as a separate entity.

1 5. When I received the Notice from the Utilities and Transportation Commission (UTC)
2 regarding the hearing today, my husband and I took immediate action to dissolve Garza Wine
3 Tours LLC with the Washington Secretary of State and the Department of Revenue. Attached
4 hereto as Exhibit A are true and correct copies of documents obtained from the Secretary of State
5 and Department of Revenue's websites showing the voluntary dissolution and closure of Garza
6 Wine Tours LLC.


7 6. In addition, my husband has taken steps to register "Garza Wine Tours" as a trade
8 name of A Plus Taxi LLC and has submitted an Application for Charter and Excursion Carrier
9 Services Certificate under A Plus Taxi LLC, listing "Garza Wine Tours" as a trade name.

10 7. We have updated our website (www.garzawinetours.net) to show that Garza Wine
11 Tours is operating under A Plus Taxi LLC. Attached hereto as Exhibit B is a true and correct
12 copy of the website's current contents.

13 8. I have also closed the bank account for Garza Wine Tours LLC with Banner Bank.
14 Attached hereto as Exhibit C is a true and correct copy of the letter I received from Banner Bank
15 regarding the account's closure.

16 I declare under penalty of perjury under the laws of the State of Washington that the
17 foregoing is true and correct.

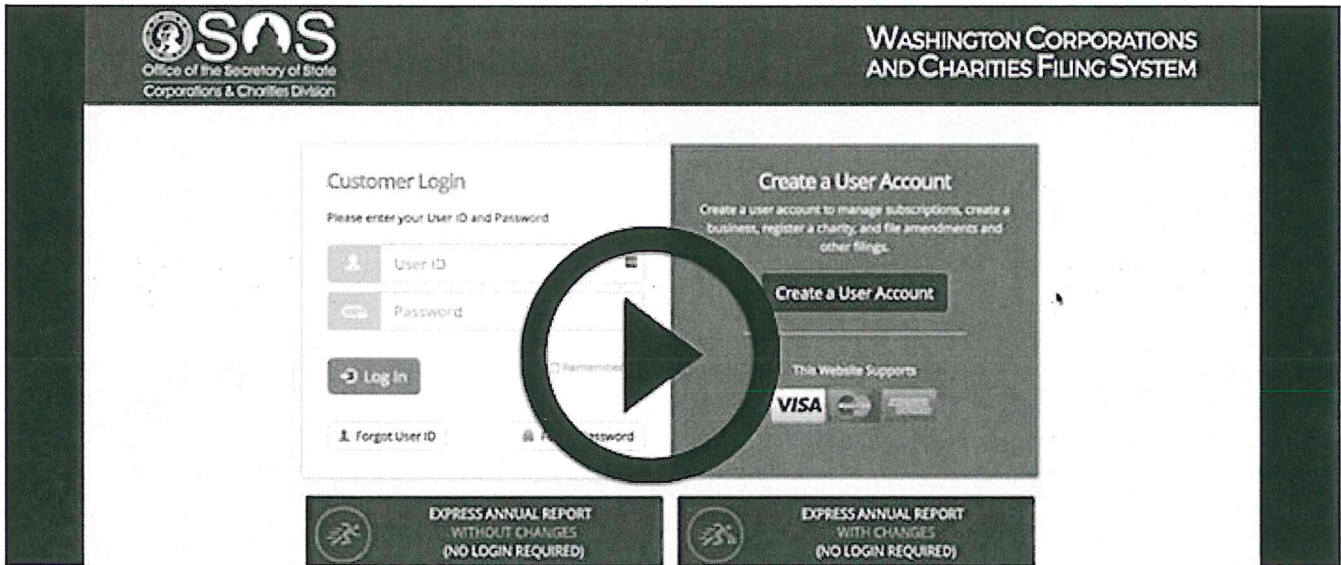

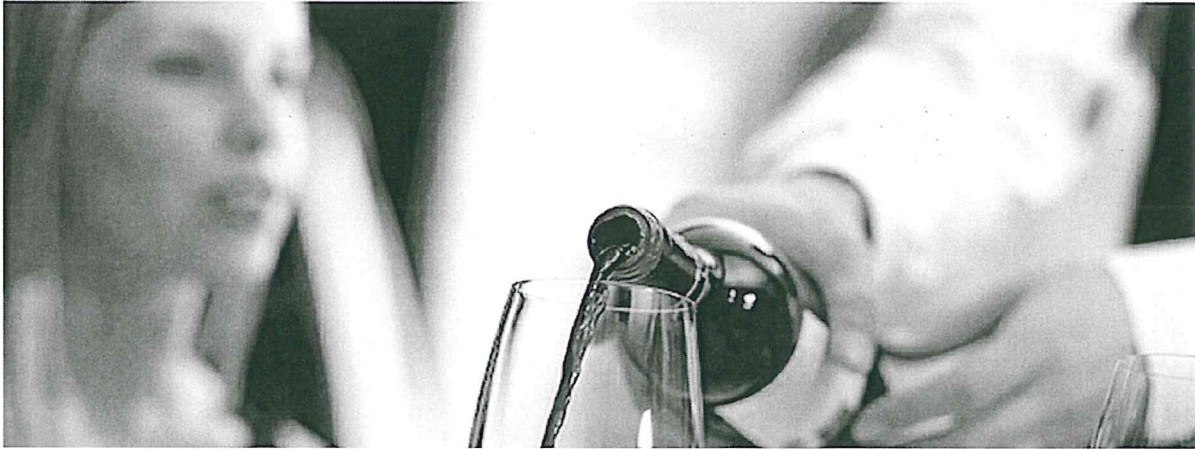
