Helping our customers use energy wisely is important to us. Each year, our customers achieve significant energy savings and receive rebates and incentives through Avista's energy efficiency programs. The Commission approves the amount of funding for these important programs through a portion of our customers' energy rates.

On May 31, 2018, Avista filed proposed changes to its electric and natural gas energy efficiency tariffs to adjust the amount of funding needed to run the programs. This includes the rebates and incentives paid to customers, so that the level of customer funding aligns with the costs to deliver the programs.

Changes in Rates - If approved, residential electric customers in Washington could expect to see a \$0.84 per month increase (from \$87.33 per month to \$88.17 per month) and residential natural gas customers in Washington could expect to see a \$0.52 per month increase (from \$50.66 per month to \$51.18 per month) in the price they pay for energy, based on average monthly usage (938 kWhs and 65 therms). These changes would begin Sept. 1, 2018.
