### RATE INCREASE NOTICE FOR MULTI-FAMILY CONTAINER SERVICES

Dear Customer:

November 30, 2018

American Disposal Co., Inc. has filed a request for a rate increase with the Washington Utilities and Transportation Commission (WUTC). The last general rate increase was approved by the WUTC June 1, 2016. Since that time, we have experienced higher costs for employee wages, benefits, fuel, truck equipment and have completed facility improvements.

If approved, the proposed rates below will become effective January 1, 2019. The rate per pick-up will increase as follows:

Effective January 1, 2019, American Disposal Company, Inc. will merge with Murrey's Disposal Company, Inc. You will not experience any change in service level following this merger; however your bills will be addressed from Murrey's Disposal after January 1, 2019.

The Commission has the authority to set final rates that may be either lower or higher from the Company's request, depending on the results of its investigation. Commission staff will make a recommendation to the Commissioners at an open meeting in Olympia, which is scheduled for 9:30 a.m. on December 28, 2018.
