I W.; thence south along, the west lines of Secs. 12 and 13, T. 25 N., R. 1 W., to the southwest corner of said Sec. 13 ; thence west along the north line of Sec. 23, T. 25 N., R. 1 W., to the northwest corner of said Sec. 23; thence south along the west lines of Secs. 23, 26, and 35, T. 25 N., R. 1 W., to the southwest corner of said Sec. 35; thence east along the south line of Sec. 35, T. 25 N., R. 1 W., to the southeast corner of Sec. 35; thence south along the west lines of Secs. I, 12, 13, 24, and 25, T. 24 N., R. I W., to the southwest corner of said Sec. 25 ; thence west along the north lines of Secs. 35 and 34, T. 24 N., R. I W., to the northwest corner of said Sec. 34; thence south along the west line of said Sec, 34 and along the west lines of Secs. 3, IO, 15, 22, 27, and 34 , T. 23 N., R. I W. to the southwest corner of said Sec. 34; thence east along the south lines of Secs. 34, 35, and 36, T. 23 N., R. I E.; thence south along the west line of Sec. 25 T. 26 N., R. 1 E., to the southwest corner of said Sec. 25 ; thence east along the south line of said sec. 25 to the southeast corner of said Sec. 25 ; thence north along, the east line of Secs. 25,24 and 13, T. 26 N., R. 1 E., to the northeast corner of said Sec. 13; thence west along the north line of Sec. 13, T. 26 N., R. 1 E., to the northwest comer of said Sec. 13; thence north along the east line of Sec. 11 and 2, T. 26 N., R. 1 E. and the east line of Sec. 35, 26, and 23, T. 27 N., R. 1 E., to the northeast comer of said Sec. 23; thence west along the north line of Sec. 23, T. 27 N., R. 1 E., to a point where the north line of said Sec. 23 intersects the easterly meander line of Hood Canal, the point of beginning.
