Dear Commercial Customer,

This is to notify you of a proposed change to commercial service rates for solid waste collection in Benton County where Basin Disposal, Inc. operates. Should the Washington Utilities and Transportation Commission (Commission) approve the proposal, customers will experience a rate increase throughout most classes of service as follows:

As you may be aware, it has been nearly six years since our last general rate case. In that time, Basin Disposal, Inc. experienced significant increases in costs that are essential to delivering services, including labor, insurance, fuel, maintenance expenses, along with federal and state employment taxes. In addition, the company continues to acquire new assets to ensure it can deliver the safest, most efficient, and reliable service possible. If approved, the proposed rates will become effective on June 1, 2023.

The proposed rate changes for our Commercial services range from approximately -27.34% to 14.15% and not all offered services are listed above. If you have questions about the proposed rate changes, you may contact the company at (509)547-2476.

The Commission has the authority to set final rates that may be either lower or higher than the company's request, depending on the results of its investigation.
