## Collection Services Billed Every Two Months

As you may be aware, it has been nearly thirteen years since our last general rate case. In that time, Basin Disposal of Yakima, LLC has experienced significant increases in costs that are essential to delivering services, including labor, insurance, fuel, maintenance expenses, along with federal and state employment taxes. In addition, the company continues to acquire new assets to ensure it can deliver the safest, most efficient and reliable service possible. If approved, the proposed rates will become effective on June 1, 2023.

The proposed rate increase for our Residential services ranges from approximately 22.68% to 50.71%, and not all offered services are listed above. If you have questions about the proposed rate increase, you may contact the company at (509) 547-2476.

The Commission has the authority to set final rates that may be either lower or higher than the company's request, depending on the results of its investigation.
