Re: UG-230763 – Annual Purchased Gas Cost and Deferred Gas Cost Amortization Adjustments and Combined Effects of all November 1, 2023 Rate Changes – Replacement Tariff Sheets DO NOT REDOCKET

On September 15, 2023, Northwest Natural Gas Company, dba NW Natural (NW Natural or Company), filed tariff revisions in this docket relating to its annual purchased gas adjustment and combined effects of all the rate changes proposed for an effective date of November 1, 2023.

The purpose of this filing is to provide replacement pages for the tariff schedules reflecting the combined effects for all rate changes proposed for an effective date of November 1, 2023, as listed below. These tariff sheets reflect an effective date of November 1, 2023. The form for a request of less than statutory notice is enclosed. A revised Exhibit B is also included.

The tariff sheets for Schedules 200, 201 and 203 filed on September 15, 2023 remain unchanged.

The combined effects portion of the September 15, 2023 filing in this docket reflected all rates expected to become effective on November 1, 2023. Since that time, on October 18, 2023, NW Natural requested in docket UG-230739 to move the effective date of Schedule 231 from November 1, 2023 to January 1, 2024. As a result, the enclosed proposed tariff sheets for Schedules 1, 2, 3, 27, 41, 42 and 43 have been updated to reflect the removal of Schedule 231 to accurately reflect all rates expected to become effective on November 1, 2023.

The combined effect of the rate changes proposed to become effective November 1, 2023, is a decrease to the average monthly bills in the primary rate schedules as follows: Residential Schedule 2 bills will decrease by 14.3% and commercial Schedule 3 bills will decrease 7.7%. The combined result of all components of the rate changes would be a decrease in the Company's revenues from its Washington operations of \$10,456,530, or 10.25%.
