Re: UG-250458 - NW Natural's Petition for TEN Pilot Project Order

Northwest Natural Gas Company, dba NW Natural ("NW Natural" or the "Company"), herewith files a petition with the Washington Utilities and Transportation Commission (the "Commission") for an order acknowledging the Company's proposed thermal energy network ("TEN") pilot project in Vancouver, Washington. NW Natural is also petitioning the Commission to use an alternative process from what is specified in RCW 80.28.470(1) to estimate the cost to deploy a thermal energy network pilot project.

NW Natural is disclosing certain information that is confidential and constitutes "valuable commercial information" as defined by WAC 480-07-160(2) and should be protected from public inspection, examination and copying.
