FIFTH ADDENDUM TO AGREEMENT CONCERNING OPERATION OF WASHINGTON DATA DISTRIBUTION CENTER

THIS ADDENDUM to the Agreement Concerning Operation of Washington Data Distribution Center ("DDC Agreement") is entered into this day of 1997, by and among the Washington Exchange Carrier Association ("WECA"), a Washington nonprofit corporation, Electric Lightwave, Inc. ("ELI"), a Washington corporation, TCG Seattle ("TCG"), a New York general partnership, US WEST Communications, Inc. ("USWC"), a Colorado corporation, GTE Northwest Incorporated ("GTENW"), a Washington corporation, United Telephone Company of the Northwest ("United"), an Oregon corporation, MFS Intelenet of Washington, Inc. ("MFS"), a Washington corporation, and Rainier Cable, Inc. ("Rainier"), a Washington corporation.

RECITALS

- 1. WECA, USWC, and GTENW have entered into the DDC Agreement dated the 16th day of May, 1996 and other telecommunications providers have since become parties to the DDC Agreement. The DDC Agreement contemplates that other telecommunications providers will become parties to that Agreement.
- 2. Rainier is operating as a provider of local telecommunications services within the state of Washington and as a provider of intraLATA toll within the state of Washington and desires to enter into the DDC Agreement.
- **NOW, THEREFORE,** in consideration of the mutual promises and benefits contained herein, the parties hereto agree as follows:

AGREEMENT

1. At such time as Rainier operates in the manner of a PTC by routing 1+ intraLATA traffic, in whole or in part, to itself, the allocation of WECA's charges under Paragraph 4.6 of the DDC Agreement shall be made among the PTCs (Rainier, USWC, GTENW, and others) in proportion to each PTC's messages processed by the Data Distribution Center relate to the total messages of all PTCs processed by the Data Distribution Center. For this purpose, a PTC's messages means those messages that apply to intraLATA toll traffic carried by that PTC.

By way of illustration, the following is an example of the allocation of costs:

- 2. In addition to all other responsibilities of PTC contained in the DDC Agreement, Rainier shall perform all duties and responsibilities contained in Article 7 DDC Operations GTENW Responsibilities, Section 3.1 Receipt of Records, and Section 8.1 WECA Audits, which for purposes of this Addendum only shall be amended to substitute Rainier for GTENW.
- 3. Section 16.9 <u>Notices</u> is amended to add the following notice address at the end of the section:

- **4.** Except to the extent that the DDC Agreement has been amended by Paragraphs 1, 2, and 3 above, the DDC Agreement shall remain in full force and effect and by this Addendum Rainier shall be treated as and shall become a party to the DDC Agreement.
- **5.** Rainier agrees to pay for the applicable costs as described on Exhibit 1, attached hereto and made a part hereof by this reference.
- **6.** This Addendum may be executed in two or more counterparts, each of which will be deemed an original, but all of which together constitute one and the same instrument. This Addendum may be executed by facsimile, which will be deemed an original signature.
