If the crossings are closed, for the year following each closure, all of the farm equipment identified in supplemental answer to Data Request No. 22 will be required to travel on SR 22 and other public roads.

Owners of the farm equipment include, but are not limited to T & K Farms, Zechinno Farms, Philip Sealock Farms, Dean Oswalt, Craig Oswalt, D & S Farms and Ranches, SP Farms, Crop Production Services, Simplot, and Husch & Husch Fertilizer and Chemicals.

The above-described farm equipment will be moved from farm land on both sides of the BNSF line to farm land on the other side of the BNSF line as part of routine farming operations of, among others, T & K Farms, Zechinno Farms, Philip Sealock Farms, Dean Oswalt, Craig Oswalt, D & S Farms and Ranches, SP Farms, and the routine business operation of Crop Production Services, and Husch & Husch Fertilizer and Chemicals. Anticipated dates of travel for the year following closure of the crossings depend on the crop planted, weather conditions, market conditions and machinery availability, and therefore cannot be anticipated with any level of precision. The farming season in general begins in April and runs through harvest in September/October.

Alternate routes that these entities will be required to use are as follows:

• If the N. Stevens Road railroad at-grade crossing is closed, the shortest alternate route for moving farm equipment from T & K Farms' property on the north side of the BNSF line to its property on the south side of the BNSF line involves taking S. Track Road to the northwest for approximately 1.4 miles, turning south and crossing the BNSF line at the Meyers Road crossing, and turning onto and travelling along SR 22 for approximately 1 mile in a southeasterly direction. The route is reversed when moving farm equipment from the south side of the BNSF line to the north side of the BNSF line.

- If the Barnhart Road railroad at-grade crossing is closed, the shortest alternate route for moving farm equipment to and from acreage farmed by Zechinno Farms south of the BNSF line in the vicinity of Barnhart Road involves travelling south on Satus Longhouse Road across the BNSF line to SR 22, then travelling about two miles in a northwest direction on SR 22. There are two narrow bridge crossings within this two-mile stretch of SR 22.
- If the N. Stevens Road railroad at-grade crossing is closed, the closest alternate route for farm equipment of SP Farms to move between SP farmland on both sides of the BNSF line in the vicinity of N. Stevens Road is about a mile to the southeast on S. Track Road near N. Harris Road. Because N. Harris Road has a bridge with a weight limit, this route is unavailable for the transport of heavy farm equipment. As a result, some farm equipment will be required to travel southeast to the crossing at Wapenish Road and then back along SR 22 for a distance of approximately 1.1 miles. Alternatively, farm equipment could travel northwest to the crossing at Meyers Road and then back along SR 22 for a distance of approximately 1.5 miles.
- Farm equipment utilized by Dean Oswalt, Craig Oswalt and Oswalt Farms uses the Barnhart Road crossing to access acreage south of SR 22. The alternate route involves crossing the BNSF line at Indian Church Road and travelling east on SR 22.
- Farm equipment utilized by Sealock Farms and D & S Farms and Ranches use the N. Stevens Road crossing. Because farming operations are spread out, alternate routes will vary but include those routes utilized by T & K Farms and SP Farms.
- Farm equipment utilized by Crop Production Services, Simplot, and Husch & Husch Fertilizer and Chemicals use both the N. Stevens Road and Barnhart Road crossings. In the event these railroad at-grade crossings are closed, these companies' equipment (primarily TerraGators, RoGators and semi-trucks) will use alternate routes to include those utilized by T & K Farms, Zechinno Farms and SP Farms.
