The Cascade Natural Gas Corporation, a Washington corporation, filed with the Commission on July 19, 1963, in Cause No. U-9469, an application to amend its Certificate of Public Convenience and Necessity to Operate a Gas Plant for Hire, No. 4 amended, to include additional area contiguous to its presently certificated areas in and adjacent to the city of Othello, Adams County and Grant County, Washington.

The Commission, in Cause No. U-9394, dated November 30, 1962, amended Cascade's Certificate of Public Convenience and Necessity to include the city of Othello and adjacent areas in Adams County and Grant County. The certificated areas included the proposed right-of-way for a gas transmission pipeline from Othello to the gas supplier's city gate station. Cascade now states that a review of the proposed pipeline route shows a material reduction of the pipeline costs will result from following existing county roads instead of securing a private right-of-way. The company's present application to amend its Certificate includes the new area to be transversed by the change in the route of the proposed pipeline.

FINDINGS OF FACT

1. Cascade Natural Gas Corporation, a Washington corporation, operates a gas plant for hire in this state and is subject to the jurisdiction of this Commission.
2. Cascade Natural Gas Corporation has heretofore been issued Certificate of Public Convenience and Necessity to Operate a Gas Plant for Hire No. 4 amended.
3. Cascade Natural Gas Corporation filed an application that its Certificate of Public Convenience and Necessity to Operate a Gas Plant for Hire be amended to encompass additional areas contiguous to its presently certificated area in Adams County.
4. The operation of a gas plant for hire in the additional areas requested by the Cascade Natural Gas Corporation is required by public convenience and necessity.
5. The Certificate of Public Convenience and Necessity to Operate a Gas Plant for Hire presently held by the Cascade

Natural Gas Corporation should be amended to encompass the additional area applied for in this cause.

O R D E R

1. IT IS HEREBY ORDERED That the application of the Cascade Natural Gas Corporation to amend its Certificate of Public Convenience and Necessity to Operate a Gas Plant for Hire to encompass additional areas contiguous to its presently certificated area in Adams County, is approved and the company's present Certificate of Public Convenience and Necessity to Operate a Gas Plant for Hire be amended to encompass Adams and Grant Counties' areas delineated as follows:

All of the incorporated area of the city of Othello and Bruce (unincorporated) and additional portions of Adams and Grant Counties described as follows:

Beginning at the northwest corner of Sec. 33, T. 17 N., R. 30 E.; thence south along the west lines of said Sec. 33 and Sec. 4, T. 16 N., R. 30 E., to the southwest corner of said Sec. 4; thence west along the north line of Sec. 8 to the northwest corner of Sec. 8; thence south along the west line of Sec. 8 to the southwest corner of Sec. 8; thence west along the north line of Sec. 18 to the northwest corner of Sec. 18; thence south along the west line of Sec. 18 to the southwest corner of Sec. 18; thence west along the north lines of Sec. 24 and 23, T. 16 N., R. 29 E., to the northwest corner of said Sec. 23; thence south along the west line of Sec. 23 to the southwest corner of Sec. 23; thence west along the north lines of Secs. 27 and 28 to the northwest corner of Sec. 28; thence south along the west lines of Secs. 28 and 33, T. 16 N., R. 29 E., and Secs. 4 and 9, T. 15 N., R. 29 E., to the southwest corner of said Sec. 9; thence east along the south lines of Secs. 9, 10 and 11 to the southeast corner of Sec. 11; thence north along the east lines of Secs. 11 and 2 to the northeast corner of Sec. 2; thence east along the south lines of Sec. 36, T. 16 N., R. 29 E. and Secs. 31, 32, 33 and 34, T. 16 N., R. 30 E., to the southeast corner of said Sec. 34; thence north along the east line of Secs. 34, 27 and 22 to the northeast corner of Sec. 22; thence east along the south line of Sec. 14, to the southeast corner of Sec. 14; thence north along the east lines of Secs. 14, 11 and 2, T. 16 N., R. 30 E., and along the east line of Sec. 35, T. 17 N., R. 30 E., to the northeast corner of said Sec. 35; thence west along the north lines of Secs. 35, 34 and 33, T. 17 N., R. 30 E., to the northwest corner of said Sec. 33, the point of beginning,

as further shown on Appendix A-16 (amended) attached hereto and by this reference made a part hereof.

2. IT IS FURTHER ORDERED That the Certificate of Public Convenience and Necessity to Operate a Gas Plant for Hire issued pursuant to Order Paragraph No. 1 above, supersedes and cancels Certificate of Public Convenience and Necessity to Operate a Gas Plant for Hire No. 4, as amended and issued to Cascade Natural Gas Corporation on July 3, 1963, in Cause No. U-9467. Said Certificate of July 3, 1963, should be forthwith returned to this Commission.

3. IT IS FURTHER ORDERED That the Certificate issued pursuant to Order Paragraph No. 1 above, is subject to the terms, conditions and provisions of the Orders in Cause Nos. U-8841, U-8843, U-8937, U-9047, U-9052, U-9194, U-9238, U-9239, U-9263, U-9364, U-9360, U-9388, U-9394 and U-9407, U-9450, and U-9467, pursuant to which Cascade Natural Gas Corporation was issued its present Certificate.

4. IT IS FURTHER ORDERED That jurisdiction over this Cause is retained to effectuate the provisions of this Order.

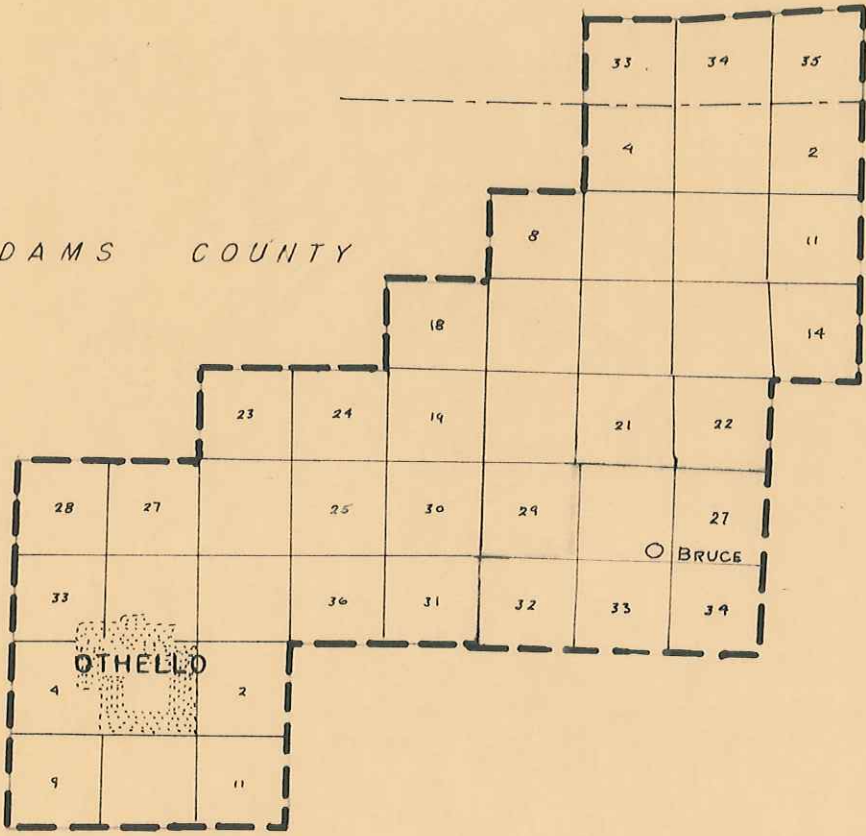
