1 **SYNOPSIS:** *The Commission affirms and adopts an Initial Order thereby granting CWA, Inc., d/b/a Central Washington Airporter (CWA) an extension of its certificate of public convenience and necessity under Certificate No. C-01073, permitting it to provide intercity passenger and express service between Yakima, Ellensburg, and Cle Elum.*

2 **NATURE OF PROCEEDING:** In this Order the Commission reviews an initial order that proposed to grant the application of CWA for an extension of its authority to provide passenger service between Yakima, Ellensburg, and Cle Elum.

3 **INITIAL ORDER:** An initial order was entered on January 12, 2005, by Administrative Law Judge Theodora M. Mace proposing that the application of CWA, Inc, Inc., d/b/a Central Washington Airporter, for an extension of its certificate of public convenience and necessity to provide passenger and express service between Yakima, Ellensburg, and Cle Elum be granted.

4 **PETITION FOR REVIEW:** No petition for administrative review was filed within the 20 days allowed by rule for filing. The Commission has reviewed the proposed order and the evidence of record and believes that the findings, the conclusions, and the order are consistent with the record. In accordance with RCW 34.05.464 and WAC 480-07-825(7), the Commission accepts the findings of fact and conclusions of law, and adopts the Initial Order as its own, for purposes of this proceeding.
