- On May 31, 2007, the Washington Utilities and Transportation Commission (Commission) entered Order TS-070019 authorizing a lease of authority contained in Certificate of Public Convenience and Necessity BC-95, held by Island Mariner Cruises, Inc., to Island Commuter Service, LLC, d/b/a Island Commuter Service (Island Commuter Service).
- The approved lease agreement between Island Mariner Cruises, Inc., and Island Commuter Service, was scheduled to expired on May 31, 2022. March 14, 2012, the companies filed a letter with the Commission requesting that the lease be withdrawn, and stating that, effective with the lease withdrawal and a corresponding lease withdrawal in TS-070020, Island Commuter Service will no longer be an operating entity regulated by the Commission.
- Therefore, certificate BC-95 should be amended and reissued to reinstate the operating authority of Island Mariner Cruises, Inc.

### <u>ORDER</u>

#### THE COMMISSION ORDERS:

4 (1) That certificate BC-95, standing in the name of Island Mariner Cruises, Inc., be amended and reissued per the attached Appendix A to reinstate authority previously excluded from service while it was under lease to Island Commuter Service.

- 5 (2) Island Commuter Service, LLC, d/b/a Island Commuter Service, will no longer be an operating entity regulated by the Commission.
- 6 (3) The tariff and time schedule on file with the Commission for Certificate of Public Convenience and Necessity BC-95 will become effective at 12:01 a.m. on the day following the service date of this Order.
