NOTICE OF OPPORTUNITY TO SUBMIT WRITTEN COMMENTS ON PROPOSED RULES (By Friday, April 25, 2008) and NOTICE OF PROPOSED RULE ADOPTION HEARING (Set for Thursday, May 15, 2008, at 1:30 p.m.)

Re: Rulemaking to Consider Amending WAC 480-93, Relating to Gas Companies - Safety, Docket PG-070975

TO ALL INTERESTED PERSONS:

This letter is to inform you of the progress made in the Washington Utilities and Transportation Commission's (Commission) rulemaking in Docket PG-070975 to consider possible corrections and clarifications to selected sections of WAC 480-93 to reflect changes in RCW Title 80 and 81 resulting from the passage of Substitute Senate Bill 5225 during the 2007 legislative session. This letter also provides notice of an opportunity to file written comments on proposed rules and participate in the formal rule adoption hearing.

On March 19, 2008, the Commission filed a notice of proposed rulemaking (CR-102) in this docket with the Code Reviser. The proposal would provide amendments to update definitions and in addition update the penalty rule in WAC 480-93-223 to be consistent with federal law, delete a requirement in WAC 480-93-200, modify the quarterly fee installment dates in WAC 480-93-240(3) and update the reference date in the adoption by reference rule in WAC 480-93-999(1)(a). This action begins the final part of the rulemaking process, which includes a written comment period, a public adoption hearing, and a decision by the Commission.

THE COMMISSION GIVES NOTICE of your opportunity to submit written comments on the proposed rules by filing with the Commission Executive Secretary either by electronic transmission as described below, or by physical delivery to 1300 S. The proposed rules, as filed with the Code Reviser, are available for inspection on the commission's web site at <u>www.utc.wa.gov/070975</u>. The Commission will send you a paper copy of the proposed rules or will send the proposal via electronic mail, if you ask.
