16	EXAMINATION
17	BY MR. FASSIO:
18	Q Good morning. Can you please state and spell
19	your first and last name for the record?
20	A Amy Andrews, A-M-Y, A-N-D-R-E-W-S.
21	Q Who is your employer?
22	A Utilities and Transportation Commission.
23	Q And what is your position with the Commission?
24	A I am a regulatory analyst.
25	Q How long have you held this position?

- 1 A I have been with the Commission for two and a
- 2 half years.
- 3 Q Could you please describe your duties as they
- 4 relate to these cases?
- 5 A My responsibilities are to investigate whether
- 6 companies regulated by the Commission are in
- 7 compliance with the rules regarding companies to file
- 8 their annual report and pay the regulatory fees.
- 9 Q And are you familiar with the rules that are
- 10 at issue in this case?
- 11 A Yes, I am.
- 12 Q And briefly, what do those rules require?
- 13 A They require the companies to file their
- 14 annual report and pay the regulatory fees by May 1st,
- 15 with exception of the charter and excursion industry,
- which their regulatory fees are due on December 31st.
- 17 Q And can you briefly summarize the particular
- 18 rules that are at issue in these cases?
- 19 A Yes. For the auto transportation companies
- and charter and excursion companies that Washington
- 21 Administrative Code is 480-30-071, for the solid waste
- companies that is WAC 480-70-071, for the household
- good carriers that is 480-15-480, and for the
- telecommunication companies that is 480-120-382.
- 25 Q Has the Commission allowed companies to file

- 1 for an extension of time to file an annual report as
- 2 long as it is received prior to May 1st?
- 3 A Yes, it does.
- 4 Q And any request for an extension is always
- 5 subject to Commission approval in order to be
- 6 effective; is that right?
- 7 A That is correct.
- 8 Q Whose responsibility is it to ensure that the
- 9 annual report and regulatory fees are timely filed and
- 10 paid?
- 11 A That is the company's responsibility.
- 12 Q Briefly, for charter and excursion carriers,
- 13 has the Commission recently changed its rules
- 14 regarding when the annual reports are due?
- 15 A Yes, it did. For the 2013 reporting year,
- 16 charter and excursion companies were then required to
- pay the regulatory fees by December 31st, with the
- 18 change being the annual report was not due until
- 19 May 1st.
- 20 Q And previously the annual reports, were they
- 21 due on December 31st of that --
- 22 A That's correct.
- 23 Q -- year?
- 24 Can you describe briefly what the Commission
- 25 did prior to May 1st, 2014, in regards to the rules

- 1 requiring annual reports and regulatory fees with
- 2 respect to the industries presented at the hearing
- 3 this morning?
- 4 A Yes. On February 28th the 2013 annual report
- 5 and 2014 regulatory fee packets were mailed out to all
- 6 active regulated companies. The instructions in that
- 7 annual report completion page instructed companies
- 8 they were to be completed and returned to the
- 9 Commission no later than May 1st to avoid enforcement
- 10 action. The instructions also informed the company
- 11 that they did have the right to request an extension
- 12 for the report.
- 13 Q And you have prepared an exhibit in each one
- 14 of the dockets that's Exhibit AA1. It's an annual
- 15 report packet. Are those, in each of the dockets,
- 16 copies of the annual report packets that were mailed
- 17 to the company?
- 18 A Yes, they are.
- 19 MR. FASSIO: I would like at this time
- 20 to either have the Commission take judicial notice of
- 21 the annual report packets that were mailed or to admit
- 22 Exhibits AA1 in each of the dockets today.
- JUDGE PEARSON: The Commission will take
- 24 judicial notice of the packets.
- 25 BY MR. FASSIO:

- 1 Q If a company did not receive this mailing for
- 2 whatever reason, whose responsibility is it to obtain
- 3 the appropriate forms?
- 4 A It is the company's responsibility.
- 5 Q And whose responsibility is it to make sure
- 6 that a regulated company maintains a current business
- 7 address on file with the Commission?
- 8 A That is also the company's responsibility.
- 9 Q Did the Commission take enforcement action
- 10 against those companies that failed to file their
- annual report by May 1st, 2014, and failed to timely
- 12 request for an extension?
- 13 A Yes, it did. Penalty assessments were issued.
- O And how did the Commission calculate the
- penalty assessments against the companies in the
- 16 dockets at issue today?
- 17 A The penalties were assessed based on \$100 per
- 18 business day late after the May 1st deadline.
- 19 Q And when the -- for failure to file a report
- 20 failure, do you mean failure to file a complete report
- 21 or report of any kind?
- 22 A The report does have to be complete.
- 23 Q So if the Commission receives -- does the
- 24 Commission consider an annual report that's filed but
- 25 may be missing certain required elements to be

- incomplete for purposes of that filing?
- 2 A That would be correct.
- 3 Q In approximately 9 of the 12 dockets that are
- 4 set for a hearing today, the companies were assessed
- 5 \$1,000 penalties. Can you explain what that \$1,000
- 6 penalty amount represents?
- 7 A Yes, the \$1,000 penalty represents ten
- 8 business days following May 1st deadline, which would
- 9 have been May 15th.
- 10 Q And have you checked the Commission's records
- 11 recently to verify whether any companies have come
- into compliance with the annual report and regulatory
- 13 fee requirements since that penalty assessment?
- 14 A Yes, I did.
- 15 Q And when was the last time that you checked?
- 16 A Monday, August 25th.

20	until 9:45, to present your case. Please proceed when
21	you are ready.
22	MR. MANDERVILLE: Well, I just was a
23	little bit surprised about the deadline. I was used
24	to paying a \$25 regulatory fee in the past. The
25	changes, once I got them and I saw that the

- 1 packet that was -- how involved it was, I had to go to
- 2 my tax person and get -- have him figure out the
- 3 numbers because I'm not a real good numbers person.
- 4 So he did that.
- 5 And the other -- there's a lot of other
- 6 questions I've had about some of the other -- the
- 7 details of how much -- you know, how many passengers
- 8 I've carried over the year, and just -- it seemed like
- 9 it was a huge difference between the -- last year and
- 10 this year, as far as the regulations and the changes
- 11 that were made and I wasn't quite ready for that.
- 12 I'm a sole proprietor, I don't have any
- employees, so everything has to be done by me.
- Sometimes it's a little bit overwhelming with the
- 15 paperwork and the accounting and all the other things
- 16 that are involved. It just -- I was under the
- impression that it was still under the
- 18 December 31st -- or January 31st, when it was due,
- 19 like in years past. The amount was -- has gone up
- 20 from, like I said, \$25 per vehicle, which I only have
- 21 the one, and it's gone up over 10 -- over -- well,
- it's going to be over \$200 now. The -- I'm a small
- 23 business. A \$1,000 fine is huge for me. I don't
- 24 believe it's the fairest way -- to just have a flat
- 25 \$1,000 fine for everybody is quite fair.

7	JUDGE PEARSON: Okay. The time is now
8	approximately 9:50, so you will have until 9:55 to
9	present your case. Go ahead and proceed when you are
10	ready.
11	MR. PRIGMORE: Okay. So first of all I
12	made a name change to Tux Ride, LLC, and that is I
13	kept the Lady in a Limo business, but I kept we
14	just pretty much changed the name. When I put in for
15	the change of address I did not receive any documents
16	containing any of this stuff to the new address. I
17	actually got an electronic e-mail that said I was not
18	in compliance and I had a fine for \$1,000. I called
19	the UTC immediately. We figured out what the problem

9	the proper notation. If I had had it I wouldn't even
10	be here at this point.
11	JUDGE PEARSON: Okay, thank you.
12	I see Staff has a second exhibit in this
13	docket. The exhibit marked AA2 is the company's
14	annual report filed June 3rd, 2014. That is a
15	commission record I will take judicial notice of.
16	Does Staff have additional questions?
17	MR. FASSIO: Not of Mr. Prigmore, but we
18	do have a couple of questions for Ms. Andrews.
19	JUDGE PEARSON: Okay.

21	EXAMINATION
22	BY MR. FASSIO:
23	Q So regarding has the as of May 15th, had
24	the Commission received the company's 2013 annual
25	report?

- 1 A No, it had not.
- 2 Q And as of today, however, has the company come
- 3 into compliance by filing its complete annual report?
- 4 A Yes, it has.
- 5 Q And when did the company file that complete
- 6 annual report?
- 7 A On June 3rd.
- 8 O And the exhibit that we submitted and the
- 9 Commission has taken judicial notice of, is that a
- 10 copy of that annual report that was filed on June 3rd?
- 11 A Yes, it is.
- 12 Q To the best of your knowledge, is the company
- currently in compliance with respect to regulatory
- 14 fees for 2014?
- 15 A Yes, it is.
- 16 Q Has the company taken any other action
- 17 recently with respect to the company?
- 18 A Yes, it was -- there was a transfer on
- 19 authority that was signed and dated and filed with the
- 20 Commission on April 23rd of 2014, under Docket
- 21 TE-140740.
- 22 Q And approximately when was the Commission
- order that authorized that transfer?
- 24 A That order was served on May 23rd of 2014.
- 25 Q So at the time that the annual report was due,

- 1 he had applied for transfer of authority but that had
- 2 yet to be approved?
- 3 A That's correct.
- 4 Q To your knowledge, has this company been
- 5 previously found in violation of the rule at issue
- 6 today?
- 7 A No.
- 8 Q Based on your investigation and the carrier's
- 9 testimony today, are you prepared to make a
- 10 recommendation?
- 11 A Yes, we are.
- 12 Q And what is your recommendation?
- 13 A Staff would recommend the Commission does find
- 14 the company has committed ten violations of WAC
- 15 480-30-071. Because of the transfer authority issue
- 16 that occurred during the annual report deadline and
- 17 due to the recent changes in the charter and excursion
- industry rules, we do recommend the penalty be
- 19 mitigated to \$200.
- JUDGE PEARSON: Thank you.
- 21 Mr. Prigmore, do you wish to respond?
- MR. PRIGMORE: So you're saying the
- penalty would be \$200?
- JUDGE PEARSON: That's Staff's
- 25 recommendation, yes.

- 1 MR. PRIGMORE: Well, I appreciate you
- 2 lowering it, I guess.
- JUDGE PEARSON: I will still have to
- 4 issue a decision --

MR. ROBERSON: Well, I've been in

business for about five years. I have always been, I

- don't know how you would explain it, doing everything
- 2 right to my best ability. I received this this year
- 3 and it had a lot of other documents with it that I
- 4 didn't understand. I called up WTC [sic]. I spoke
- 5 with -- oh, I can't recall the lady's name. I think
- 6 it's in my letter. Anyway, I called her up and I
- 7 asked her to explain to me how much information she
- 8 actually needs, and all of this information. She said
- 9 just the basics, so I did that. I said, Okay, trying
- 10 to get it all sufficient and go with the new modern
- 11 age of computers. I'm not that computer literate.
- 12 She gave me an e-mail to send it to, so I did.
- 13 My understanding of what the e-mail was, was
- 14 ADons@utc.washington.gov (phonetic). I sent that off.
- 15 Back then it was dated -- March 6th is when I dated
- 16 it, signed it and completed it. I assumed that it got
- there in time. Well, apparently it didn't get there
- due to the e-mail being wrong, as a clerical error in
- 19 what I understood.
- 20 When I did receive the penalty situation
- 21 information, I got a hold of them immediately. She
- 22 goes, No, that's not the right e-mail address. And at
- 23 that time she confirmed that she received it with that
- 24 new e-mail address. The first time I sent it I didn't
- 25 get any confirmation that -- I don't know if you guys

- 1 do that. I didn't get any confirmation that it was
- 2 received. I just got off the phone, sent it, and left
- 3 it as a completed order.
- 4 So at that time I felt that it was in
- 5 compliance and was done, until I received the
- 6 information for the penalty.
- JUDGE PEARSON: Okay. And have you

## 1 EXAMINATION

- 2 BY MR. FASSIO:
- 3 Q Ms. Andrews, did the Commission receive this
- 4 company's annual report by May 1st?
- 5 A No, it did not.
- 6 Q When did the Commission actually receive the
- 7 company's complete annual report?
- 8 A May 29th.
- 9 Q Can you just briefly describe your
- 10 recollection of contacts that you had with
- 11 Mr. Roberson after May 1st?
- 12 A Sure. It was on May 5th that Mr. Roberson
- 13 contacted the Commission, it was myself, via telephone
- 14 for assistance in completing the annual report. I did
- 15 walk him through each of the schedules to let him know
- 16 which ones were required for the charter and excursion
- and which were not. At that point I did verbally
- provide my e-mail address to him to expedite his
- 19 report being received by the Commission. I did not
- 20 receive the report at that time.
- 21 On May 29th, again Mr. Roberson contacted the
- 22 Commission after receiving his penalty assessment and
- 23 during this conversation it was discovered that the
- 24 e-mail that he had sent the report to was an incorrect
- 25 e-mail address. The address again was provided and

- 1 the report was received on the 29th, on the same day.
- 2 Q To the best of your knowledge is this company
- 3 currently in compliance with respect to regulatory
- 4 fees for 2014?
- 5 A Yes, it is.
- 6 Q Has this company previously violated WAC
- 7 480-30-071?
- 8 A Yes, a penalty assessment was issued in
- 9 TE-130210 for the 2012 annual report.
- 10 Q Based on your investigation and the company's
- 11 testimony today and the written response, are you
- 12 prepared to make a recommendation at this time?
- 13 A Yes, I am.
- 14 Q And what is your recommendation?
- 15 A Staff would recommend the Commission find the
- 16 company committed two violations of WAC 480-30-071,
- 17 with consideration of the May 5th report, with the
- 18 attempted submission, for a mitigated total assessed
- 19 penalty of \$200.
- JUDGE PEARSON: Thank you.
- 21 Mr. Roberson, do you want to briefly respond
- 22 to Staff's recommendation?
- MR. ROBERSON: Well, I appreciate the
- 24 discount in the penalty, but I feel I shouldn't have
- 25 to make anything due to a clerical error. Just

- because I don't hear good doesn't mean I should be
- 2 penalized for it, you know. I have been, in the past,
- 3 on time and in compliance with Washington Utilities
- 4 and Transportation, in everything that I have done.
- JUDGE PEARSON: Okay. Well, thank you
- for taking the time to come here today, Mr. Roberson.
- 7 You are free to go now.
- 8 MR. ROBERSON: Thank you.
- 9 JUDGE PEARSON: Thank you.

- 21 Docket TE-141086, Yellow Arrow Lines, LLC.
- Good morning.

- MR. CAMARILLO: Thank you.
- 3 The main reason we actually are here,
- 4 obviously because we received the notation of \$1,000
- 5 fine. However, one of the main reasons we are
- 6 contesting it is because in the packet that we
- 7 received in March there was an opportunity to file an
- 8 extension, which we did. However, nowhere in the
- 9 paperwork that we received from WUTC was stated that
- 10 all our responses had to be basically certified or
- 11 registered, so that there was proof that we
- 12 actually -- either party received the documentation.
- I believe the WUTC never received our letter.
- 14 Basically we received first notation when we received
- an e-mail, and registered mail also to our address,
- 16 that we were fined. We object to that because the
- 17 reason we requested an extension, although you guys
- 18 didn't receive, or they didn't receive it, is because
- 19 Yellow Arrow Lines, you know, since basically the
- 20 middle of the March until end of May, they were in,
- 21 you know, basically meetings so they can merge with
- another company and expand our business, so we asked
- 23 for an extension.
- 24 We didn't know after the merger basically who
- 25 was going to be the president of the company. At the

- 1 end of the situation they added two members and
- 2 several other vehicles. Right now, I believe last
- 3 week, I believe Yellow Arrow Lines basically will not
- 4 be under the jurisdiction of the WUTC because of all
- 5 the federal requirements by the Federal Motor Carrier
- 6 Safety Administration. Now we have a couple of
- 7 busses, they are capacity over 50 passengers, and
- 8 before, for the last year, it was only two vans of 16
- 9 passengers each.
- 10 Also, in March I spoke to Tina from the WUTC
- office, and basically I wanted to find out if we
- 12 needed to file the report, because legally our
- 13 business is borderline between charter and another
- 14 basically category. We do not charge fare for
- passengers. We are basically contracted with the
- 16 company we ended up actually merging in a way. They
- pay us to transport their passengers from Washington
- 18 state to Los Angeles, California. So sometimes they
- 19 have passengers in small areas, like where our office
- 20 is located, in Othello. We transport those passengers
- 21 to the main office where -- or the main terminal,
- 22 where they take the other bus.
- 23 Tina explained to us that indeed we needed to
- 24 send that documentation. I filed the extension, which
- 25 was not received, but then we ended up filing our

- 1 report. It was late. However, a few days later the
- 2 whole report was sent back to us stating that we
- 3 already have basically paid. So it seems that some
- 4 representatives in the WUTC were thinking we were
- 5 borderline in different categories. We were forced to
- 6 file the report and then have to be penalized \$1,000,
- 7 however, they send it back to us.
- 8 We don't know right now, at this point -- I
- 9 understand there has been a lot of changes in the law,
- 10 and requisitions and everything else. However, you
- 11 know, at one point, you know, do we know for sure, you
- 12 know, that that happened. So that's why we are
- 13 contesting today, because it seems that there was a
- 14 lot of misinformation. We were not aware that the
- 15 extension was not received.
- 16 Also, I believe the WUTC is doing the best
- that it can, you know, to try to inform every single
- one of us that are working out there. However, if you
- 19 want something that I could recommend the company in
- 20 this case, you know, or the department for that
- 21 matter, is that we do get an e-mail of the penalty
- 22 fines, we do get, you know, certified letters that we
- 23 were penalized in that regard, but no one single time
- 24 did we ever receive an e-mail just to tell us, hey,
- 25 your extension period is expiring and we have not

- 1 received your documentation. If that would have
- 2 happened, we would have known at that point that, you
- 3 know, the document was not received. We probably
- 4 would have paid or, you know, filed that, you know,
- 5 documentation the same day or maybe following day,
- 6 rather than paying \$1,000 fine. It would probably be
- 7 just \$100 fine.
- 8 That's basically the information that I have,
- 9 I can provide today, our testimony from the company.
- 10 JUDGE PEARSON: Okay, thank you.
- I see Staff has two exhibits in this docket.
- 12 The exhibit marked AA2 is the company's annual report
- filed June 2nd, 2014, and that's a Commission record
- 14 that I will take judicial notice of.
- Does Staff have further testimony and a
- 16 recommendation?
- MR. FASSIO: We do, Your Honor.

- 19 EXAMINATION
- 20 BY MR. FASSIO:
- 21 Q Ms. Andrews, did the Commission receive this
- 22 company's annual report by May 1st?
- 23 A No, it did not.
- Q When did the Commission actually receive the
- 25 company's complete annual report?

- 1 A June 2nd.
- 2 Q In its request for a hearing and also in
- 3 testimony today the company indicated that they
- 4 submitted a request for extension in April, prior to
- 5 the deadline that is stated in the instructions. To
- 6 your knowledge, is there any record of the Commission
- 7 having received an extension request?
- 8 A No, there is not.
- 9 Q To the best of your knowledge is this company
- 10 currently in compliance with respect to regulatory
- 11 fees for 2014?
- 12 A Yes, it is.
- 13 Q There was some testimony today about something
- being returned to the company. Do you have any
- 15 knowledge of that and can you explain?
- 16 A Yes.
- 17 Q Okay.
- 18 A The portion that was returned to the company
- 19 were the regulatory fees that were paid in June.
- 20 Those fees were returned because they were based off
- of the auto transportation authority and not the
- 22 charter and excursion authority. They paid additional
- fees that were not due. The report was not returned.
- 24 Q Has this company previously violated WAC
- 25 480-30-071?

- 1 A No.
- 2 Q Based on your investigation and the company's
- 3 written response on record and their testimony today,
- 4 are you prepared to make a recommendation at this
- 5 time?
- 6 A Yes, I am.
- 7 Q And what is your recommendation in this case?
- 8 A Staff recommends the Commission find the
- 9 company committed ten violations of WAC 480-30-071.
- 10 We also recommend mitigation in the amount of \$200, as
- 11 this is the company's first violation. We also
- 12 believe in the good faith effort made by the company
- 13 to request the extension, despite the Commission not
- 14 receiving the documents, and due to the recent changes
- in the charter and excursion industry carrier rules.
- JUDGE PEARSON: Thank you.
- Do you wish to respond?
- MR. CAMARILLO: No.
- 19 JUDGE PEARSON: Okay. Thank you for
- 20 taking the time to come here today. You are free to
- 21 go.
- Okay. Docket TG-141168, Ludtke Pacific
- 23 Trucking, Inc.
- Good morning.
- MR. LUDTKE: Good morning.

16	MR. LUDTKE: I admit it.
17	JUDGE PEARSON: Okay. Since we didn't
18	receive any exhibits from you in advance, I'm ready to
19	take your testimony. If you will please stand and
20	raise your right hand.
21	MR. LUDTKE: (Complies.)
22	
23	LLOYD LUDTKE, witness herein, having been
24	first duly sworn on oath, was
25	examined and testified as follows:

- JUDGE PEARSON: Thank you.
- 3 The time is now approximately 12 minutes after
- 4 10:00. You will have five minutes to present your
- 5 case, so go ahead and proceed when you are ready.
- 6 MR. LUDTKE: Okay. I wrote it out --
- JUDGE PEARSON: Okay.
- 8 MR. LUDTKE: -- so I wouldn't forget
- 9 anything.
- JUDGE PEARSON: Okay.
- 11 MR. LUDTKE: Our business started in
- 12 1940, incorporated in 1946, and continues today with
- 13 29 trucks and some 48 employees. We operate
- intrastate and interstate. I'm going to brag a little
- 15 here and tell you that just over this last weekend our
- 16 company was honored with the safety award for a small
- 17 fleet operating under 5 million miles, by the
- 18 Washington State Patrol and our trucking association.
- I am here today to respectfully ask for
- 20 mitigation on a fine imposed on us, which I believe to
- 21 be excessive. Our net revenue for the six months of
- this year is approximately \$67,000. This fine of
- 23 1,000 represents nearly 1 percent of that. I believe
- you have in front of you my explanation for the
- 25 failure to timely send in our report, but I would just

- 1 like to explain a little further on the circumstances.
- 2 We had a valued employee who had been with us
- 3 for some 12 years. She always tried to do her best to
- 4 meet all required deadlines. I will be honest here
- 5 and tell you that I did not know about the previous
- 6 untimely reports, of which I believe there were two.
- 7 It wasn't until I had to fire her for incompetence
- 8 that this and several other matters were discovered.
- 9 In our history of a company that has been operating
- 10 for some 74 years and my controlling involvement for
- 11 some 40 years, I have had my share of penalties, but
- they all seemed fair and just and circumstances
- 13 surrounding were justified. I really feel this one is
- 14 excessive, as the information on our company has not
- 15 changed that much over the years. And I would be
- 16 eager to find out what the information is used for and
- 17 what damage the lateness of the report affected any
- 18 outcome.
- 19 As you are aware, I have paid the fine, as per
- 20 a letter from your commission instructing me to do so,
- 21 and I am here today on a letter from your commission
- granting me the opportunity to personally appeal the
- 23 fine, which I received two days after I paid the fine.
- 24 I thank you for listening and giving me the
- opportunity to have my day in court.

25 BY MR. FASSIO:

Τ,	JUDGE PEARSON: Thank you, Mr. Ludtke.
2	Can you tell me what steps that you are going
3	to take to ensure this doesn't happen again going
4	forward?
5	MR. LUDTKE: The steps I have taken is
6	that I have hired a new accountant. I can absolutely
7	unequivocally tell you that there will never be a late
8	report because he seems to be the one that that
9	takes these kinds of things to heart and knows what he
10	has to do. And I can assure that if he doesn't, I
11	will.
12	JUDGE PEARSON: Okay, thank you.
13	I see that Staff has several exhibits in this
14	docket. The exhibit marked AA2 is the company's
15	annual report filed June 6th, 2014, and the exhibit
16	marked AA3 contains two notices of penalty assessments
17	for previously late-filed annual reports in Docket
18	TG-091023 for 2010 and TG-130876 for 2012. These are
19	all commission records that I will take judicial
20	notice of. Is Staff prepared to testify further or
21	make a recommendation?
22	MR. FASSIO: Yes, Your Honor.
23	
24	EXAMINATION

- 1 Q Ms. Andrews, did the Commission receive this
- company's annual report by May 1st?
- 3 A No.
- 4 Q When did the Commission actually receive the
- 5 company's complete annual report?
- 6 A On June 6th.
- 7 Q Did the company ever file an extension
- 8 request?
- 9 A Yes.
- 10 Q And when was that extension request made?
- 11 A The extension request was received on May 1.
- 12 Q Was that extension request denied?
- 13 A It was.
- 14 Q And why was that denied?
- 15 A The extension requests were due prior to
- 16 May 1.
- 17 Q To the best of your knowledge is this company
- currently in compliance with respect to regulatory
- 19 fees for 2014?
- 20 A Yes, it is.
- 21 Q And speaking briefly, has the company ever
- 22 been previously penalized for violation of WAC
- 23 480-30-071?
- 24 A Yes.
- Q And are those the two penalty assessments that

- 1 the Commission has taken judicial notice of today?
- 2 A Yes.
- 3 Q Based on your investigation and the company's
- 4 written submission and the testimony today, is Staff
- 5 prepared to make a recommendation at this time?
- 6 A Yes, it is.
- 7 O And what is Staff's recommendation?
- 8 A Staff does not support further mitigation of
- 9 the penalty due to multiple prior violations.
- JUDGE PEARSON: Thank you.
- Do you wish to respond, Mr. Ludtke?
- 12 MR. LUDTKE: No. Thank you very much.
- 13 JUDGE PEARSON: Thank you for taking the
- 14 time to come here.
- 15 Dockets TV-140933, A & E, Inc., and TV-140970,
- 16 Morgan Transfer, Inc. I will hear these dockets
- 17 simultaneously because I understand you are
- 18 representing both companies --
- MR. MICHAEL: Sure.
- JUDGE PEARSON: -- and that you will
- 21 present an identical set of facts for each case; is
- that correct?
- MR. MICHAEL: Correct.
- JUDGE PEARSON: Okay.
- 25 Can you state your name and address for the

1	record, spelling your last name for the court
2	reporter?
3	MR. MICHAEL: Mike Michael,

6	JUDGE PEARSON: Okay. And your phone
7	number and e-mail address?
8	MR. MICHAEL: (360) 528-3180, and e-mail

L O	JUDGE PEARSON: And what is your
11	position with each company?
12	MR. MICHAEL: President of both.
13	JUDGE PEARSON: Okay. And are you
L 4	contesting or admitting the violations today?
15	MR. MICHAEL: Contesting.
16	JUDGE PEARSON: And since we didn't
L7	receive any exhibits from you in advance, I can take
18	your testimony at this time. If you will stand and
L 9	raise your right hand.
20	MR. MICHAEL: (Complies.)
21	
22	MIKE MICHAEL, witness herein, having been
23	first duly sworn on oath, was

examined and testified as follows:

1 JUDGE PEARSON: Okay, thank you. The
```

- 2 time is now approximately 10:20, so you will have five
- 3 minutes to present your case. Go ahead and proceed
- 4 when you are ready.
- 5 MR. MICHAEL: It will take more like 30
- 6 seconds.
- JUDGE PEARSON: Okay.
- 8 MR. MICHAEL: Many years I've done the
- 9 same thing. I put this report in with the first
- 10 quarter reports for employment security, L & I,
- 11 Department of Revenue, federal unemployment, 941s,
- 12 everything that goes out that same day. This went out
- on April 30, as it always does, postmarked with the
- 14 rest of them. I don't know if you have a postmarked
- 15 envelope here or not.
- I guess it just comes down to do you honor a
- 17 postmark or not. If you don't, then you received it
- 18 on the 2nd from the post office, and that's what it
- is; and if you honor a postmark, then it's -- then it
- 20 should be on time.
- 21 We have never been late before. And I do the
- 22 same thing every year. They all go out at the same...
- JUDGE PEARSON: Okay. So Commission
- 24 rules do require that the reports be received by
- 25 May 1st, not postmarked by May 1st. In the future you

- 1 will want to take that into consideration --
- 2 MR. MICHAEL: Okay.
- JUDGE PEARSON: -- when you are sending
- 4 your reports in.
- 5 MR. MICHAEL: So other years I probably
- 6 have been late, then. I've never heard about it.
- JUDGE PEARSON: The rules have become
- 8 stricter in the past few years, and our enforcement
- 9 has become stricter as well, for late-filed annual
- 10 reports, so that's most likely why.
- 11 Okay. So I see that Staff has filed a second
- 12 exhibit in this docket. The exhibit marked AA2,
- 13 actually in both dockets, is the company's annual
- 14 report filed May 2nd, 2014. That's for Dockets
- 15 TV-140933 and 140970. Those are Commission records
- 16 that I will take judicial notice of.
- 17 If Staff would like to proceed.
- MR. FASSIO: Thank you, Your Honor.
- 19
- 20 EXAMINATION
- 21 BY MR. FASSIO:
- 22 Q The annual reports that were received on
- 23 May 2nd, how many days past due would that have been?
- 24 A One.
- 25 Q And the company has addressed the issue of

- 1 postmarking on April 30th. The Commission also took
- 2 judicial notice of the annual report packet. Do those
- 3 instructions contain any information as to when the
- 4 Commission considers a report filed?
- 5 A The instructions pages do say they need to be
- 6 received by May 1.
- 7 Q To the best of your knowledge, are each of
- 8 these companies, A & E, Inc., and Morgan Transfer,
- 9 currently in compliance with respect to regulatory
- 10 fees for 2014?
- 11 A Yes, both companies.
- 12 Q According to Commission regards, have A & E,
- 13 Inc., or Morgan Transfer ever previously been
- penalized for violation of WAC 480-15-480?
- 15 A No.
- 16 Q Based on your investigation and the company's
- submission and testimony today, are you prepared to
- make a recommendation at this time?
- 19 A I am.
- 20 Q And what is Staff's recommendation?
- 21 A Staff recommends the Commission find the
- companies committed one violation of WAC 480-15-480.
- 23 As this is both companies' first violation, Staff
- 24 recommends mitigation of \$25 per day for a total
- 25 penalty of \$25 against both companies.

- 1 JUDGE PEARSON: So a total penalty of
- 2 \$50?
- MS. ANDREWS: Correct.
- 4 JUDGE PEARSON: Okay.
- 5 Do you wish to respond?
- 6 MR. MICHAEL: I don't.
- 7 JUDGE PEARSON: Thank you for taking the
- 8 time to come here today.
- 9 MR. MICHAEL: Thank you.
- JUDGE PEARSON: Docket TV-140988,
- 11 Seattle Select Moving, LLC.
- 12 Good morning.
- MR. HANSON: Good morning.
- JUDGE PEARSON: Please state your name
- 15 and address for the record and spell your last name
- 16 for the court reporter.
- MR. HANSON: Mike Hanson, H-A-N-S-O-N.
- JUDGE PEARSON: And your address?
- 19 MR. HANSON: 6857 47th Avenue
- Northeast, Seattle, Washington 98115.
- JUDGE PEARSON: Okay. And your phone
- 22 number and e-mail address, please?
- 23 MR. HANSON: (206) 486-4301,
- 24 SeattleSelectMoving@gmail.com.
- JUDGE PEARSON: And what position do you

1	nold with the company, Mr. Hanson?
2	MR. HANSON: I'm co-owner and operator.
3	JUDGE PEARSON: And are you contesting
4	or admitting the violations today?
5	MR. HANSON: Kind of both, if that's
6	possible.
7	JUDGE PEARSON: It's not possible.
8	MR. HANSON: Oh.
9	JUDGE PEARSON: So are you acknowledging
10	that your
11	MR. HANSON: Yeah.
12	JUDGE PEARSON: annual report was
13	late-filed?
14	MR. HANSON: Oh, yeah.
15	JUDGE PEARSON: So you are admitting the
16	violations but seeking to reduce the penalty, correct?
17	MR. HANSON: Or, yeah, abolish it.
1.0	
18	JUDGE PEARSON: Okay. So we didn't
19	JUDGE PEARSON: Okay. So we didn't receive any exhibits from you, so if you will just
19	receive any exhibits from you, so if you will just

3	JUDGE PEARSON: Thank you.
4	The time is approximately 10:25, so you have
5	until 10:30 to present your case. Go ahead and
6	proceed when you are ready.
7	MR. HANSON: I'm new, kind of learning
8	as I go along. My buddy had a truck, he said let's
9	start a moving company, so we did. We promptly
10	received a letter that told us to stop by you know,
11	if we didn't get all our stuff in by December 19th, I
12	would have to take down the website I built and all of
13	that. We went to great lengths to get that taken care
14	of and be in compliance.
15	And then I can't remember when the class was,
16	but we came to the first class offered and we learned
17	everything about the bill of lading, estimated cost of
18	goods, we went through all of that. When we received
19	our temporary permit we received a letter. I'm just
20	going to read a sentence out of it. "To ensure you
21	receive technical assistance during your evaluation
22	period, we have assigned a motor carrier staff person
23	to help your company become familiar with the rules
24	and regulations governing household good carriers."
25	I just feel like, okay, we did receive the

- 1 letter and -- well, my business partner did --
- 2 completely forgot about it. I think if it's an
- 3 important thing maybe we would receive a phone call
- 4 saying, hey. I don't even know who you assigned to
- 5 me. Do you guys?
- 6 MS. ANDREWS: No.
- 7 MR. HANSON: Yeah, neither do I. So I
- 8 don't know who is assisting or helping me comply,
- 9 but -- I don't know, all we do is receive threats from
- 10 you guys and like bad letters and nothing else. You
- 11 know, I got a letter recently saying that we didn't
- 12 give someone an estimated cost of goods, that they had
- 13 put on the customer survey form. That person did, I
- 14 was there for it. And I asked the -- whoever I spoke
- 15 with -- you know, it was just a warning letter -- I
- said, Call that customer, I want this off my record.
- 17 Of course she didn't. She didn't call that
- 18 customer. I called that customer and she never
- 19 received a call. No investigation. So who is
- 20 helping? It says "help," it says here "assistance,"
- I'm getting none, and so now I have \$1,000 fine.
- I'm a new business, I'm a small business.
- 23 That's it. I still haven't filed. It didn't even
- 24 strike me until I saw other people bring in their
- 25 reports. Like, oh, I probably should have had my

- 1 report.
- 2 But I would like to see that that fine be
- 3 removed and me get an extension. I can have it in by
- 4 September 10th, like you gave that first gentleman,
- 5 easy. I keep very detailed records. And also, if you
- 6 guys could provide me with whoever was assigned to me
- 7 to help, that would be helpful.
- 8 JUDGE PEARSON: Okay. So what I can
- 9 tell you about that letter is that it is referring to
- 10 a motor carrier safety specialist, so to help you with
- 11 safety requirements for your vehicles.
- MR. HANSON: Why doesn't it say that?
- JUDGE PEARSON: I'm not sure why the
- letter doesn't say that, but that's what that's
- 15 referring to. There are lots of other sections of the
- 16 Commission that you can call. When you attended the
- 17 household goods training you were given contact
- information about who you could contact for technical
- 19 assistance, with bills of lading and estimates and
- 20 things of that nature.
- MR. HANSON: Yeah.
- JUDGE PEARSON: So if you ever call the
- 23 Commission, we are happy to assist you and direct you
- 24 to whoever you need to speak to.
- MR. HANSON: I called the Commission

- because I -- you guys give us these customer survey
- forms that we have to -- so made my own, because I
- 3 wanted it nice. I have a nice presentation and
- 4 everything. I called and I said, Is it okay if I make
- 5 my own, so it looks like this? I never received a
- 6 call back, not once. I also called to report
- 7 violators and I got a call back like two and a half
- 8 months later. And it wasn't even to actually report a
- 9 violator, I just wanted to see what you guys would do.
- JUDGE PEARSON: Okay.
- MR. HANSON: Obviously its...
- 12 JUDGE PEARSON: Well, that's not what we
- 13 are here to talk about today.
- 14 With respect to your annual report, you say
- 15 you can get it in by September 10th. Can you get it
- 16 in this week?
- MR. HANSON: Yeah.
- 18 JUDGE PEARSON: Okay. If you can get it
- in by Friday at noon on August 29th, because what's
- 20 going to happen is, you know, I only have ten days to
- 21 issue the orders. If I know that you filed it by
- 22 Friday at noon, then I can take that into
- 23 consideration and consider mitigating your penalty.
- If you haven't filed it, then I can't grant you any
- 25 mitigation. We have to receive that report in order

- for you to have mitigation, okay?
- 2 MR. HANSON: Okay.
- JUDGE PEARSON: So --
- 4 MR. HANSON: So what happens after I
- 5 turn it in?
- JUDGE PEARSON: After you turn it in,
- 7 then Ms. Andrews will notify me and I can consider
- 8 that when writing the order.
- 9 MR. HANSON: Okay.
- JUDGE PEARSON: And then you won't be
- facing losing your permit, because that's the next
- 12 step, is that Staff will file complaints to cancel the
- 13 authority of companies who haven't yet filed their
- 14 annual reports.
- MR. HANSON: Okay.
- JUDGE PEARSON: Okay.
- 17 MR. HANSON: Obviously I don't want to
- 18 lose my authority.
- JUDGE PEARSON: Right.
- 20 MR. HANSON: I mean I think the record
- 21 should show that we -- you know, we have gone to great
- lengths to comply.
- JUDGE PEARSON: It's really important
- that you get your annual report filed.
- MR. HANSON: Yeah.

- 1 JUDGE PEARSON: Okay. Is Staff prepared
- 2 to give further testimony and make a recommendation?
- 3 MR. FASSIO: Yes, Your Honor.

- 5 EXAMINATION
- 6 BY MR. FASSIO:
- 7 Q For the record, Ms. Andrews, did the
- 8 Commission receive this company's annual report by
- 9 May 1st?
- 10 A No.
- 11 Q And to the best of your knowledge, is this
- 12 company currently in compliance with respect to
- 13 regulatory fees for 2014?
- 14 A No.
- 15 Q Would that information be available, whether
- or not they are, once that annual report is filed?
- 17 A Yes, once we have the annual report I will be
- 18 able to make that determination.
- 19 Q This company is a new company, as they have
- 20 testified. Can you confirm that the company has ever
- 21 previously been penalized for violation of WAC
- 22 480-15-480?
- 23 A It has not.
- 24 Q So based on your investigation and the
- 25 testimony today, are you prepared to make a

- 1 recommendation at this time?
- 2 A We are.
- 3 Q And what is your recommendation?
- 4 A Staff does recommend the Commission find the
- 5 company committed ten violations of WAC 480-15-480.
- 6 As this is the company's first violation, Staff
- 7 recommends mitigating the penalty to \$25 per day, for
- 8 a total of \$250, only on the condition that the
- 9 company submits the completed annual report and pays
- 10 regulatory fees by the Friday, August 29th at noon
- 11 deadline provided by the judge.
- JUDGE PEARSON: Do you wish to respond?
- MR. HANSON: I still think the penalty
- 14 is kind of steep.
- JUDGE PEARSON: Okay. Thank you.
- 16 Thank you for taking the time to come here today.
- Okay. Docket TV-140998, Richard Worrell.
- MR. WORRELL: Hi.
- JUDGE PEARSON: Good morning.
- MR. WORRELL: Good morning.
- JUDGE PEARSON: If you could please
- 22 state your name and address for the record and spell
- 23 your last name.
- MR. HANSON: My name is Richard Worrell,
- 25 W-O-R-R-E-L-L. My address is 710 140th Place

1	Southwest, Lynnwood, Washington 98087.
2	JUDGE PEARSON: Okay. And you your
3	phone number and e-mail address.
4	MR. HANSON: (425) 787-3444, and my
5	e-mail is richiro, which is R-I-C-H-I-R-O,

7	JUDGE PEARSON: Okay. And you are the
8	owner of the company, correct?
9	MR. WORRELL: Yes, ma'am.
10	JUDGE PEARSON: Okay. And are you
11	contesting or admitting the violations today?
12	MR. WORRELL: Contesting.
13	JUDGE PEARSON: Okay. Okay. We didn't
14	receive any exhibits from you in advance, so if you
15	will stand and raise your right hand I will swear you
16	in and take your testimony.
17	MR. WORRELL: (Complies.)
18	
19	RICHARD D. WORRELL, witness herein, having been
20	first duly sworn on oath, was
21	examined and testified as follows
22	
23	JUDGE PEARSON: Okay, thank you.
24	The time is now approximately 10:30, so you

25 have five minutes to present your case. Go ahead and

- 1 begin when you are ready.
- 2 MR. WORRELL: I didn't bring any
- 3 exhibits because I noticed the exhibit list was
- 4 basically what I needed to prove or whatever.
- JUDGE PEARSON: Okay.
- 6 MR. WORRELL: When I first got my
- 7 letter -- let me make sure I still -- the letter said
- 8 that I was late. It didn't say anything, it just --
- 9 no description, just said you're late. So I was
- 10 like -- well, actually, first, before I go through
- 11 that, I checked my e-mail on May 5th. I'm not always
- in access to my e-mail because of my road travels.
- 13 I'm not much of an e-mail person. Maybe I should be,
- it's probably my fault.
- But in this case I didn't leave out anything
- that would cause the numbers to differ or the money
- 17 amount being paid, so therefore -- you guys received
- 18 my file on April 28th, so it was on time. I forgot to
- 19 put the mileage in there, that's all. That's all that
- 20 it was. I forgot to put the mileage on there. And so
- 21 I was given an e-mail.
- 22 Like I said -- I think like one of the
- gentlemen said before, I kind of agree with, I think
- 24 the route out, when a situation is really simple like
- 25 this, is a phone call. On your packet, I would assume

- 1 this is in list of priority: You need a name, you
- 2 need an address of who you are dealing with, and you
- 3 want to get a hold of them, there's a phone number,
- 4 and last an e-mail address.
- 5 I received it on May 5th and I had
- 6 correspondence between the Staff. Literally 15
- 7 minutes later I sent it in, so it was taken care of.
- 8 I just feel that -- I just feel like just a phone call
- 9 would have -- five minutes would have handled all of
- 10 this, and then this -- all of this wouldn't have
- 11 happened and I wouldn't have had to come down here.
- 12 But I do admit that -- I mean obviously I
- didn't put it in there and that was my mistake. But I
- 14 also want to point out that I checked the year's
- 15 before filing and it's still not on there. Am I
- incurring \$100 fine every day since then?
- 17 I'm kind of thinking that I didn't put it
- in -- I'm not blaming anybody, but I didn't put it in
- 19 the year before, I didn't put it in this year, it was
- 20 a mistake, and nobody caught it before but they caught
- 21 it this year. I just feel like it just could have
- 22 been handled in like five minutes, as opposed to not
- 23 paying the fee or filing late or not getting an
- 24 extension. This was just a simple -- a line in here
- 25 that I didn't get.

- 1 JUDGE PEARSON: Okay. I can assure that
- 2 that was a Staff oversight last year, that didn't
- 3 catch that the mileage wasn't filled in. It is the
- 4 company's responsibility to ensure that the report is
- filled out totally and completely. We simply don't
- 6 have the staff resources to call every single company.
- 7 We do send out e-mails.
- 8 MR. WORRELL: Isn't that just -- I mean
- 9 I'm sorry to interrupt. Sorry.
- 10 JUDGE PEARSON: Well, sending out an
- 11 e-mail is far less time consuming, if it's a
- 12 form/template e-mail and you just send it to different
- 13 companies, than to place phone calls and try to get a
- 14 hold of people. Because it is the company's
- 15 responsibility ultimately, you know, it is a courtesy
- that the Commission sends an e-mail notifying you.
- 17 It's a courtesy that we send out the forms in
- 18 February, letting you know that you need to file an
- 19 annual report, because ultimately the responsibility
- lies with you, to make sure that your report is filed.
- 21 MR. WORRELL: Right, right, I stated
- 22 that. I know that.
- JUDGE PEARSON: Okay.
- MR. WORRELL: I'm just asking for a
- 25 little bit of lenience here. I mean -- I mean I just

- feel like a phone call might be a little bit longer in
- 2 the end, but it clears up so much, you know,
- 3 misconceptions and all of this.
- JUDGE PEARSON: Okay.
- 5 MR. WORRELL: It could have been handled
- on the 29th and not May 5th.
- JUDGE PEARSON: Okay. So what steps are
- 8 you going to take to ensure that this doesn't happen
- 9 again next year?
- 10 MR. WORRELL: I'm going to make sure I
- 11 put the miles in there. I don't have a problem with
- 12 my filings. I do everything myself, all the numbers,
- it's super easy. I just literally forgot one spot. I
- 14 almost want to say that, without causing blame,
- 15 because like I said it's on me, but I mean I missed it
- last year, no one told me about it. It's not your
- 17 responsibility, but I guess it is this year, to show
- 18 me, but it wasn't last year to show me. So, I mean
- 19 maybe subconsciously I didn't put it in there because
- 20 I didn't put it in last year. I mean I don't know.
- 21 I'm just saying --
- JUDGE PEARSON: Okay.
- MR. WORRELL: -- it's a very simple
- 24 mistake that could be cured in a matter of minutes.
- JUDGE PEARSON: Okay, thank you.

1	So I see that Staff has multiple exhibits in
2	this docket. The exhibit marked AA2 is a copy of the
3	company's incomplete annual report filed April 28th,
4	2014, the exhibit marked AA4 is a copy of the
5	company's replacement Schedule 1 page filed May 5th,
6	2014, and the exhibit marked AA5 is notice of penalty
7	assessment in Docket TV-131010 for a late-filed annual
8	report for the 2012 reporting year. The exhibits
9	marked AA2, AA4 and AA5 are all Commission records
10	that I will take judicial notice of.
11	Mr. Fassio, do you want to address the exhibit
12	marked AA3?
13	MR. FASSIO: Yes, Your Honor, I do have
14	a couple of questions and I will address that exhibit
15	for a completion of the record.
16	JUDGE PEARSON: Okay, thank you.
17	MR. FASSIO: I would just like to hand a
18	copy of that exhibit to this exhibit.
19	MR. WORRELL: I'm looking at it right
20	here.
21	
22	EXAMINATION
23	BY MR. FASSIO:

Q Ms. Andrews, I just have a few questions for 25 you, just to ensure a complete record here.

- 1 Did the Commission receive this company's
- 2 complete annual report by May 1st?
- 3 A No, it did not.
- 4 Q And what did the Commission receive?
- 5 A An incomplete report, missing mileage on
- 6 Schedule 1.
- 7 Q And did Staff contact the company regarding
- 8 the incomplete report?
- 9 A Commission Staff did e-mail the company on
- 10 April 29th.
- 11 Q And turning to your Exhibit AA3, Page 1, does
- 12 this describe -- does this show the e-mail
- 13 communication that Staff made to the company on
- 14 April 29th?
- 15 A Yes, it does.
- 16 Q And did the company respond and provide any
- 17 additional information at that time?
- 18 A Yes, it did, on May 5th.
- 19 Q And does your Exhibit AA3 also describe the
- 20 communication that you made on May 5th with the
- 21 company?
- 22 A Yes, it does.
- 23 Q So did that e-mail on May 5th complete --
- serve to complete his report?
- 25 A Yes, it does.

- 1 Q And so based on that submission on May 5th, he
- 2 was assessed a penalty for two violations; is that
- 3 right?
- 4 A That's correct.
- 5 Q To the best of your knowledge is this company
- 6 currently in compliance with respect to regulatory
- 7 fees for 2014?
- 8 A Yes, it is.
- 9 Q And according to Commission records, has this
- 10 company been previously penalized for violation --
- 11 A Yes.
- 12 Q -- of WAC 480-15-480?
- 13 A Yes, it has, in TV-131010 for the 2012 annual
- 14 report.
- 15 Q Based on your investigation, the company's
- 16 testimony today and what they have submitted in
- 17 writing, are you prepared to make a recommendation at
- 18 this time?
- 19 A Yes, I am.
- 20 Q And what is your recommendation?
- 21 A Staff recommends the Commission find the
- company committed two violations of WAC 480-15-480.
- 23 Due to the timely response of the company for the
- 24 requested information for the 2013 report and the 2012
- 25 report being accepted without mileage, Staff also

- 1 recommends mitigation of \$50 per day, as this is the
- 2 company's second violation, for a total penalty of
- 3 \$100.
- 4 JUDGE PEARSON: Okay, thank you.
- 5 Mr. Worrell, did you have any objection to
- 6 admitting Exhibit AA3 into the record?
- 7 MR. WORRELL: I just have a couple
- 8 questions on it.
- 9 JUDGE PEARSON: Sure.
- 10 MR. WORRELL: It says that it's issued
- 11 August 8th.
- JUDGE PEARSON: Okay.
- MR. WORRELL: I don't understand that.
- I mean I'm already in court way before of something
- 15 that happened in May 1st. I mean -- and all of a
- sudden in 2013, on August 8th, I'm assessed a penalty
- 17 of \$50 for a late --
- JUDGE PEARSON: Okay. That's --
- MR. WORRELL: -- filing?
- JUDGE PEARSON: That's not what I am
- 21 talking about. That's a Commission record that I have
- 22 already taken notice of. I'm talking about
- 23 Exhibit AA3. It's the e-mail correspondence between
- 24 you and Commission Staff.
- MR. WORRELL: Oh, okay.

- JUDGE PEARSON: Do you have any
- 2 objections to that?
- 3 MR. WORRELL: No.
- 4 JUDGE PEARSON: Then I will admit
- 5 Exhibit AA3.
- 6 Did you want to respond to Staff's
- 7 recommendation?
- 8 MR. WORRELL: I just -- it says right
- 9 here, Mover's incomplete annual report. I know it's
- 10 incomplete, but it says filed April 28th. I mean it
- 11 kind of goes against what you are saying here. It was
- incomplete so it wasn't really filed, but it says it
- was incomplete, filed on April 28th.
- 14 JUDGE PEARSON: It is considered filed
- when we received it, but it can be filed incomplete.
- MR. WORRELL: Okay.
- 17 JUDGE PEARSON: Reports can be filed
- 18 incomplete.
- 19 MR. WORRELL: It just sounds like --
- 20 when you say it right here, it just sounds like it
- 21 came late, you know. I did put it in on time, it just
- 22 was not...
- JUDGE PEARSON: I understand that.
- MR. WORRELL: Okay.
- JUDGE PEARSON: Well, thank you for

- 1 taking the time to come here today.
- MR. WORRELL: Thank you.
- JUDGE PEARSON: Okay. Docket UT-140922,
- 4 Telewise, LLC.
- 5 MR. POWER: Good morning.
- JUDGE PEARSON: Good morning.
- 7 Please state your name for the record and
- 8 spell your last name for the court reporter.
- 9 MR. POWER: My name is Charles, P, like
- 10 Peter, O-W-E-R.
- JUDGE PEARSON: And your address?
- 12 MR. POWER: 7023 Northeast 175th Street,
- 13 Suite H, Kenmore, Washington 98028.
- JUDGE PEARSON: Okay. And your phone
- 15 number and e-mail address?
- MR. POWER: My phone number is
- 17 (877) 771-4261. My e-mail address is
- 18 charles@telewise.com.
- 19 JUDGE PEARSON: Okay. And I understand
- you are the managing member of the company?
- MR. POWER: I am, yes.
- JUDGE PEARSON: Okay. And are you
- 23 contesting or admitting the violations today?
- MR. POWER: I am contesting.
- JUDGE PEARSON: Contesting, okay.

1	Mr. Power, you submitted several documents in
2	advance and Staff has received copies of those.
3	Does Staff have any objections?
4	MR. FASSIO: No.
5	JUDGE PEARSON: Okay.
6	MR. POWER: I was asked to bring an
7	original and three copies it said, so I have those
8	here.
9	JUDGE PEARSON: Okay. If you can
10	provide one to Mr. Fassio and one to me.
11	MR. POWER: (Complies.)
12	JUDGE PEARSON: I will admit these into
13	evidence and mark them as Exhibit CP1.
14	I am ready to take your testimony. If you
15	would stand and raise your right hand.
16	MR. POWER: Okay.
17	
18	CHARLES POWER, witness herein, having been
19	first duly sworn on oath,
20	was examined and testified
21	as follows:
22	
23	JUDGE PEARSON: The time is now just
24	after 10:40, so you have five minutes to present your
25	case. You can begin whenever you are ready.

```
1 MR. POWER: Every year Telewise mails in
```

- 2 their annual report on time, except last year, we were
- 3 a day late and paid a \$25 fine. This year we filed
- 4 electronically. We filed the income statement, the
- 5 balance sheet and the regulatory fee schedule. We
- filed the same information electronically this year
- 7 that we filed every year by paper -- or by mail. We
- 8 got the confirmation e-mail saying there were three
- 9 items that were requested, or the three items we
- 10 believe were requested, or the only three items.
- 11 It said on the confirmation e-mail that they
- 12 were received April 30th, which was one day before the
- deadline, so we thought everything was fine. June 2nd
- 14 we got a letter from the UTC saying that we didn't
- 15 file, or we didn't file a complete statement. It
- 16 didn't say what we didn't -- what we did wrong, we
- 17 weren't too sure. On June 6th we sent in a letter
- 18 saying we believe we were in compliance, we filed on
- 19 time and we filed everything. And then on -- we got a
- 20 letter June 29th saying that we were to come to the
- 21 hearing and that we were subject to \$1,000 fine.
- 22 I'm not sure -- weren't not really -- Telewise
- isn't sure what we are not in compliance with and why
- 24 we are being fined. We don't understand.
- 25 JUDGE PEARSON: Okay. So is it your

- 1 understanding that you have filed a complete annual
- 2 report as of today or not?
- MR. POWER: My understanding is we
- 4 filed -- on April 30th we filed electronically and
- 5 have the confirmation saying we did, so we feel we are
- 6 in compliance.
- JUDGE PEARSON: Okay.
- 8 MR. POWER: We don't understand how
- 9 we -- why the UTC would think we are not. We're not
- 10 sure.
- JUDGE PEARSON: Okay. I'm sure Staff
- 12 can provide more information about that.
- MR. POWER: Okay.
- 14 JUDGE PEARSON: What steps will you be
- taking to ensure that your report is received timely
- 16 next year?
- MR. POWER: Well, we believe it was
- 18 filed timely and was filed --
- 19 JUDGE PEARSON: Complete, I should say.
- 20 MR. POWER: -- one day early. We
- 21 believe it was filed -- I would like to hear from the
- 22 Commission, what we did wrong, and if there was
- 23 something we did do wrong we will make sure that...
- JUDGE PEARSON: Okay. So you are still
- 25 not clear about what was --

- 1 MR. POWER: We're not clear what we did
- 2 wrong. We filed like we do every year, we just filed
- 3 electronically.
- 4 JUDGE PEARSON: Okay.
- 5 THE WITNESS: The same information that
- 6 we filed by mail, we filed electronically. We got the
- 7 confirmation that we did file on time and there was no
- 8 indication what we did wrong.
- 9 In the letter from the UTC on June 2nd, it
- 10 said we didn't file a complete return, but there was
- 11 no indication what wasn't complete about it, so we're
- 12 not sure. We would like to know what we did wrong.
- 13 It's not clear to us, but there's something we did
- 14 wrong.
- JUDGE PEARSON: Okay, thank you.
- 16 So I see Staff has two additional exhibits in
- 17 this docket, aside from the annual report packets that
- 18 were mailed out in February. The Exhibit marked AA2
- is a copy of the company's filing receipt, regulatory
- 20 fee calculation schedule and redacted financial sheets
- 21 that were filed on April 30th, 2014, and the exhibit
- 22 marked AA3 is a notice of penalty assessment in Docket
- 23 UT-130858, for a late-filed annual report for the 2012
- 24 reporting year. Each of these exhibits are Commission
- 25 records that I will take judicial notice of.

- 1 Is Staff prepared to give further testimony
- 2 and make a recommendation?
- MR. FASSIO: Yes, Your Honor.

- 5 EXAMINATION
- 6 BY MR. FASSIO:
- 7 Q Ms. Andrews, can you confirm that the company
- 8 was sent a packet of materials on February 28th, 2014,
- 9 the annual report packet?
- 10 A Yes.
- 11 Q Did the Commission receive this company's
- 12 complete annual report, in other words, what is shown
- on each of those pages of that annual report packet,
- 14 by May 1st?
- 15 A No, it did not.
- 16 Q What exactly did the Commission receive by
- 17 May 1st?
- 18 A The Commission received the regulatory fee
- 19 sheet and a redacted set of financials, which included
- 20 the balance sheet and the income statement.
- 21 Q And based on the regulatory fee calculation
- sheet, does it indicate any regulatory fees were due?
- 23 A No regulatory fees are due.
- Q To the best of your knowledge, at that time
- 25 did the Commission receive any nonredacted financial

- 1 statements?
- 2 A No.
- 3 Q By May 1st, did the Commission receive Page 1
- 4 of the annual report?
- 5 A No.
- 6 Q Did the Commission receive Page 3 of the
- 7 annual report, the certification page?
- 8 A No.
- 9 Q Did the Commission receive Page 4 of the
- 10 annual report?
- 11 A No.
- 12 Q So just to clarify, has the Commission
- 13 received as a filing any of the documents, other than
- 14 the ones that the Commission has already taken
- judicial notice of, that we had provided as AA2?
- 16 A No.
- 17 Q In this case, did the Commission take any
- 18 particular action when that filing was made on
- 19 April 30th?
- A No, it did not.
- 21 Q And can you explain why not?
- 22 A Those documents are what is submitted when a
- 23 company is also going to be filing an extension
- 24 request, because they have to show they either owe and
- 25 have paid their regulatory fees or they have not, they

- 1 do not owe any fees.
- 2 Q Did the company request particular
- 3 confidential treatment under WAC 480-07-160 to your
- 4 knowledge?
- 5 A It was not stated per the WAC, only the
- 6 redacted markings were made.
- 7 Q So if a company wanted their filings to be
- 8 accorded confidential treatment, are there
- 9 instructions on Page 2 of that annual report form that
- 10 direct them to the appropriate Commission rules
- 11 concerning requirements for a confidential filing?
- 12 A Yes, it does.
- Q Were the documents that were submitted labeled
- 14 confidential at all?
- 15 A No, they were not.
- 16 Q And has the Commission received any unredacted
- 17 versions of those documents?
- 18 A No, it has not.
- 19 Q Does Telewise have any previous violations of
- 20 WAC 40-120-380 -- 382?
- 21 A Yes, it does. In UT-130858, for the 2012
- 22 annual report.
- 23 Q So at this time the Commission is still in --
- 24 has not received at least three of the pages of the
- 25 annual report?

```
1 A That is correct.
```

- 2 Q Based on your investigation and the company's
- 3 testimony and their written submissions today, are you
- 4 prepared to make a recommendation at this time?
- 5 A I would like to request to hold that
- 6 recommendation until the end of the hearing.
- 7 Q Okay.
- 8 JUDGE PEARSON: So if I understand
- 9 correctly, Mr. Power, you are missing -- and correct
- 10 me if I'm wrong, Ms. Andrews -- Page 1, Page 3, Page 4
- 11 and nonredacted financial sheets --
- MS. ANDREWS: Correct.
- JUDGE PEARSON: -- is that correct?
- 14 Okay.
- MR. POWER: Page 1, 3 and Page 4 of the
- 16 financial --
- MS. ANDREWS: Of the annual report.
- MR. POWER: Annual report.
- 19 JUDGE PEARSON: In addition, the
- 20 nonredacted financial sheets, so it's actually four
- 21 pieces.
- 22 MR. POWER: And if we -- okay. So to
- 23 get them -- to send them in redacted we have to get
- 24 special permission or we have to send them in
- 25 nonredacted?

- 1 JUDGE PEARSON: If you are seeking
- 2 confidential status there is a WAC that directs you
- 3 how to request that.
- 4 MR. POWER: Okay.
- 5 JUDGE PEARSON: Otherwise, we will need
- 6 the nonredacted version.
- 7 MR. POWER: Okay.
- 8 JUDGE PEARSON: So do you think you can
- 9 have those filed by Friday at noon?
- 10 MR. POWER: Friday noon at the latest,
- 11 yes.
- 12 JUDGE PEARSON: Okay, good. Do you wish
- 13 to respond to -- I guess there is nothing to respond
- 14 to right now, sorry.
- MR. POWER: I'll just get to work here.
- 16 JUDGE PEARSON: We'll come back to that.
- Okay, okay. Well, I will go ahead and call
- 18 the last docket, then.
- MR. POWER: Okay.
- JUDGE PEARSON: Okay. Docket UT-140925,
- 21 TSS Digital Services, Inc.
- 22 UNIDENTIFIED SPEAKER: Excuse me, I
- 23 think Charles gave you the originals that were
- 24 supposed to go back to our office.
- MR. POWER: No.

- 1 UNIDENTIFIED SPEAKER: Are you sure?
- JUDGE PEARSON: This does say "Original"
- 3 on it. Did you need that back?
- 4 MR. POWER: No, that's fine. That's
- 5 yours. Thank you.
- 6 JUDGE PEARSON: If you will just stick
- 7 around until we are done with this docket.
- 8 MR. POWER: Am I supposed to stay?
- JUDGE PEARSON: Yes, yes, we need you to
- 10 wait here.
- MR. POWER: I'm sorry.
- JUDGE PEARSON: Good morning.
- MR. ELLIS: Hi.
- JUDGE PEARSON: Can you state your name
- and address for the record and spell your last name
- 16 for the court reporter?
- 17 MR. ELLIS: Sure. My name is Tom Ellis,
- 18 E-L-L-I-S. My address is Post Office Box 69, Olympia,
- 19 Washington 98507. My telephone number, (360)
- 20 915-1000. My e-mail address is
- 21 tom.ellis@tssdigital.com.
- JUDGE PEARSON: Okay, thank you.
- 23 And what position do you hold with the
- 24 company?
- MR. ELLIS: I am the chief technical

officer and I sit on the board of directors. 1 JUDGE PEARSON: And are you contesting 2 3 or admitting the violations today? 4 MR. ELLIS: I am contesting. JUDGE PEARSON: Okay. So since we 5 didn't receive any exhibits from you in advance, if 6 you will go ahead and stand and raise your right hand I will take your testimony. 8 9 MR. ELLIS: Sure. 10 11 witness herein, having been TOM ELLIS, first duly sworn on oath, was 12 13 examined and testified as follows: 14 15 JUDGE PEARSON: Thank you. 16 The time is now 10:50. You have until 10:55 17 to present your case. Go ahead when you are ready. MR. ELLIS: Sure. We filed our annual 18 19 report on time, one day ahead of time. We thought it was complete. We got a notice saying that they needed 20 21 some financial statements. 22 The service that we provide is all VoIP. 23 Based on my knowledge, we didn't really need to file 24 any financial statements. We have filed financial

statements in the past. The financial statements we

- 1 have filed in the past, going back as many years as I
- 2 have found, were our corporate calendar year, not the
- 3 ando (phonetic) year. That's it. I don't believe
- 4 that we are -- should pay a penalty because we aren't
- 5 really required because everything we do is VoIP.
- 6 The Commission back in 2011 took a look at how
- 7 we do VoIP, and admitted that yes, we were doing it
- 8 correctly. That's kind of where we sit.
- 9 We have been late in the past, as far as
- 10 filing our annual reports, due to staffing problems.
- 11 We have paid whatever little penalty that was in the
- 12 past, I believe. That's about it.
- JUDGE PEARSON: Okay, thank you.
- 14 And what steps is the company taking to ensure
- that this won't happen again next year?
- MR. ELLIS: Well, we put it on the
- 17 calendar. We are only about a mile away, so we just
- 18 actually hand carry the stuff over here every year.
- 19 JUDGE PEARSON: Okay. I see that Staff
- 20 has multiple exhibits in this docket. The exhibit
- 21 marked AA2 is a copy of the company's incomplete
- 22 annual report filed April 30th, 2014, the exhibit
- 23 marked AA3 is a redacted copy of the company's
- financial statements filed May 13, 2014, and the
- 25 exhibit marked AA5 is a series of penalty assessments

- 1 issued in Dockets UT-071286, 081143 and 121016, for
- 2 late-filed annual reports for the reporting years
- 3 2006, 2007 and 2011 respectively.
- 4 AA2, AA3 and AA5 are all Commission records
- 5 that I will take notice of. And I guess, Mr. Fassio,
- 6 you will likely address AA4 in Staff's testimony and
- 7 recommendation; is that correct?
- 8 MR. FASSIO: Yes, Your Honor.
- 9 JUDGE PEARSON: Okay, go ahead and
- 10 proceed.
- 11 MR. FASSIO: I'm going to hand you a
- 12 copy of that exhibit, AA4.
- MR. ELLIS: Thanks.

- 15 EXAMINATION
- 16 BY MR. FASSIO:
- 17 Q Ms. Andrews, did the Commission receive a
- 18 complete annual report filing from this company by
- 19 May 1st?
- 20 A No.
- 21 Q The Commission filed something by May 1st.
- 22 What exactly was filed at that time?
- 23 A The Commission received an incomplete annual
- 24 report. It was missing Schedule 1, Part D, which is
- 25 the revenue confirmation, as well as the company

- 1 financials.
- 2 Q Can you describe the communications between
- 3 Staff and the company after May 1st concerning that
- 4 filing?
- 5 A On May 1st Staff contacted the company via
- 6 e-mail to notify the company of the missing
- 7 information. On May 13th, Staff contacted the company
- 8 again via e-mail to notify the company the information
- 9 has still not been received. On the same day,
- 10 May 13th, TSS Digital Services submitted the company
- 11 financials, however, they did not cover the January
- 12 through December 2013 time period as required.
- 13 Mr. Ellis wrote the financials provided
- 14 matched the company current open year. He also stated
- 15 a revised Schedule 1 should have been e-mailed. He
- then contacted me on May 13th via telephone and he
- 17 stated that the cost to have the financials redone for
- 18 the calendar year was a cost of \$100 and that
- 19 Schedule 1 was provided despite the Commission not
- 20 receiving that document.
- 21 Q So the Commission has already taken judicial
- 22 notice of the financial statements received on
- 23 May 13th.
- 24 So just to clarify, as of today the company is
- 25 not in compliance. What is it that the Commission

- 1 still requires the company to provide?
- 2 A We still require Schedule 1, Part D to be
- 3 complete, and we require the financials to cover the
- 4 January through December 2013 period.
- 5 Q To the best of your knowledge, is the company
- 6 currently in compliance with respect to any regulatory
- 7 fees for 2014?
- 8 A Yes, there were no regulatory fees due based
- 9 on the revenues.
- 10 Q And briefly, has TSS Digital Services
- 11 previously been found in violation of WAC 480-120-382?
- 12 A Yes, as the judge has already described.
- Q Based on your investigation and the company's
- 14 submissions and their testimony today, is Staff
- prepared to make a recommendation at this time?
- 16 A Yes.
- 17 Q What is Staff's recommendation?
- 18 A Staff recommends the Commission find the
- 19 company committed ten violations of WAC 480-120-382.
- 20 Staff does not recommend mitigation due to the
- 21 company's failure to submit a complete annual report
- 22 and also include the financials for the period from
- 23 January to December 2013, in addition to the previous
- 24 violations.
- 25 Q Thank you.

- 1 MR. FASSIO: At this time I move to
- 2 admit Exhibit AA4 into the record.
- JUDGE PEARSON: Okay.
- 4 Mr. Ellis, do you have any objections to
- 5 admitting the documents showing the e-mails back and
- 6 forth between you and Staff?
- 7 MR. ELLIS: No, that's fine.
- JUDGE PEARSON: I will admit
- 9 Exhibit AA4.
- 10 Mr. Ellis, are you prepared to file the
- missing pieces of the report by Friday at noon?
- 12 MR. ELLIS: So the missing pieces are
- 13 the annual report and our financials for the calendar
- 14 year; is that --
- MS. ANDREWS: That is correct.
- MR. ELLIS: And what else is missing?
- MS. ANDREWS: Schedule 1, Part D was
- 18 left blank, which is the revenue confirmation section.
- 19 MR. ELLIS: I will have to look. I'm
- 20 not sure about that, but I'll take a look and see.
- Yeah, I can file those. But I do have a
- 22 statement here.
- Over the past years that we have filed our
- 24 annual reports, they have always been our corporate
- 25 calendar year, always. We have never ever filed a

- 1 calendar year for, you know, January 1 to
- 2 December 31st, ever.
- JUDGE PEARSON: Okay. Is --
- 4 MR. ELLIS: And we've never been
- 5 questioned before.
- 6 MS. ANDREWS: I don't have any
- 7 information available at this time.
- JUDGE PEARSON: Okay, okay.
- 9 MR. ELLIS: We have all of the ones that
- 10 we have ever filed. Yeah, we went back and took a
- 11 look at them. We have always filed from October 1st
- 12 to September 31, which is our corporate calendar year.
- JUDGE PEARSON: Okay.
- MS. ANDREWS: Judge Pearson, I do recall
- that the company has had multiple years where they
- 16 reported no regulated revenues. On those particular
- 17 years. The Commission would not have required company
- 18 financials, so that could also play into it.
- JUDGE PEARSON: So something has changed
- this year, then?
- MS. ANDREWS: Yes, because --
- JUDGE PEARSON: Okay.
- MS. ANDREWS: -- they reported some
- 24 revenues.
- MR. ELLIS: I have a question.

- 1 Regulated -- now, what we filed was regulated, even
- 2 though we do VoIP. Is that still part of the
- 3 regulated amount that's on here?
- 4 MS. ANDREWS: There are very intricate
- 5 rules around that.
- 6 MR. ELLIS: I understand. That's what
- 7 I'm saying.
- 8 MS. ANDREWS: I would not be answering
- 9 that question.
- 10 MR. ELLIS: I believe that we probably
- 11 were not required to put any revenue on that line
- 12 because we do do VoIP.
- JUDGE PEARSON: We can certainly put you
- in contact with someone in the telecom section who can
- 15 answer your questions.
- MR. ELLIS: Yeah, we've got plenty of
- documentation. We have talked to you guys over many
- 18 years about this.
- 19 JUDGE PEARSON: Okay, okay. Well, as
- long as you can make sure and get it completed by
- 21 Friday, because again you will be in danger of having
- your certificate cancelled if the annual report isn't
- 23 completed. That's the next step that Staff will take.
- MR. ELLIS: Okay. I may have a problem
- 25 getting the income statement for the calendar year by

- 1 Friday --
- JUDGE PEARSON: Okay.
- 3 MR. ELLIS: -- because that's an
- 4 accountant thing.
- JUDGE PEARSON: Okay.
- 6 MR. ELLIS: You know, something's going
- 7 to have to be done as far as that is concerned, as far
- 8 as filing that calendar year one. I may have a
- 9 problem with that.
- JUDGE PEARSON: Okay.
- 11 MR. ELLIS: I mean we did file -- like I
- 12 said, we filed -- in the past years, we filed exactly
- 13 what we've always filed.
- 14 JUDGE PEARSON: Okay. Well, I will just
- 15 need you to stay in contact with Ms. Andrews, then.
- 16 Keep her posted as to the status because she will be
- 17 the Staff person who will be bringing forth the
- 18 cancellations.
- MR. ELLIS: Okay.
- JUDGE PEARSON: The more communication
- 21 you have with her the better, to not put your
- 22 authority at risk.
- MR. ELLIS: Okay.
- JUDGE PEARSON: Okay, all right.
- 25 Thank you for taking the time to come here today.

- 1 MR. ELLIS: You're welcome.
- 2 I'm just trying to find the document that I
- 3 need to file.
- 4 JUDGE PEARSON: Okay.
- 5 MR. ELLIS: Maybe I can get some help
- 6 here. Can you show me the document that we didn't
- 7 file?
- 8 MS. ANDREWS: The portion of the
- 9 Schedule 1?
- MR. ELLIS: Yes, please.
- MS. ANDREWS: Yes.
- 12 JUDGE PEARSON: Mr. Fassio, did Staff
- want to take a brief recess before recalling the last
- 14 docket?
- MR. FASSIO: We may need a minute off
- 16 the record to confirm that we are ready, but I believe
- 17 that we are prepared to move forward with the
- 18 recommendation as to the previous docket.
- JUDGE PEARSON: Okay.
- MR. ELLIS: All right. Thank you.
- JUDGE PEARSON: Thank you.
- 22 (A brief recess.)
- JUDGE PEARSON: Docket UT-140922,
- 24 Telewise, LLC. Mr. Fassio, you can proceed when you
- are ready.

## 1 EXAMINATION

- 2 BY MR. FASSIO:
- 3 Q Is Staff prepared to make a recommendation in
- 4 this case?
- 5 A Yes, we are.
- 6 Q What is Staff's recommendation regarding the
- 7 docket for Telewise, LLC?
- 8 A Staff recommends the Commission find the
- 9 company committed ten violation of WAC 480-120-382.
- 10 Staff does recommend mitigate of \$50 per day, instead
- of the \$100 per day, as we do believe that the company
- 12 had a good faith effort to file a completed annual
- 13 report. We do offer this recommendation on the
- 14 stipulation that the annual report is filed completely
- 15 with the financials by Friday at noon, August 29th.
- JUDGE PEARSON: Okay, thank you.
- Do you wish to respond?
- 18 MR. POWER: So the fine would be 500 --
- 19 MS. ANDREWS: It would be a total of 500
- 20 instead of the \$1,000.
- 21 MR. POWER: It seems now that I
- 22 understand that we did something wrong or filed
- incorrectly, however, our total revenues for the year,
- intrastate state revenues are 4,000, so a fine of 500
- would be, you know, 12 percent of our entire revenue.

- 1 It seems a little harsh, but...
- JUDGE PEARSON: I will certainly take
- 3 your revenue into consideration as well.
- 4 MR. POWER: Thank you very much.
- JUDGE PEARSON: Okay.
- 6 MR. POWER: I will make sure by Friday
- 7 we -- I just want to make it a little clearer. Now,
- 8 when you say Page 1, 3 and 4 of the annual report,
- 9 that's -- you're talking about -- you're talking
- 10 about --
- MS. ANDREWS: The cover page.
- MR. POWER: -- this?
