With the approval of and a grant from the Washington Utilities and Transportation Commission (WUTC) of \$ 25, 200 (Docket TR-180237), the City of Auburn (City) solicited bids to install 100 feet median separators on each side of an industrial spur track rail crossing of C Street SW (DOT 085661D). The track and crossing connect the BNSF Seattle Subdivision to the Boeing Company plant in Auburn. The grant was for the installation of 100 feet of median separators on either side of this crossing. The goal of the project is to discourage vehicles from going around trains crossing this passively protected crossing and to prevent collisions.

The City solicited bids from four firms to do this project. In response to the city's request for bids, one firm responded. Their bid to complete this project was \$ 35,652.00 (see the attached bid). The bid amount exceeded the grant amount received by \$10,452.00.

The City of Auburn is requesting additional funds in the amount of \$ 10,452.00 and a 30 DAY extension from the WUTC deadline of August 31, 2018 to complete this project.
