Recommendations:

- 1. Take no action, thereby allowing the tariff revisions filed by Shirona Water Company, LLC, on June 1, 2018, as revised on August 24, 2018, to become effective September 1, 2018, by operation of law.
- 2. Acknowledge the name change from Shirona Water Company, LLC to Wildwood Water Company, LLC

Discussion

On June 1, 2018, Shirona Water Company, LLC (Shirona or company), filed with the Utilities and Transportation Commission (commission) a proposed general rate increase that would generate \$4,100 (4 percent) additional annual revenue and establishment of a new Tariff WN U-1. This new tariff would replace Shirona's WN U-1 tariff and Crosswoods Water Company's WN U-2 tariff.

As part of the new tariff and this rate case, the company is also requesting a name change to Wildwood Water Company, LLC.

The company's reasons for the increase is many operating costs are now changing due to common ownership of the two formerly separate companies, to include taxes, insurance, Department of Health operating permit fees, water quality testing and repair costs. The proposed effective date is September 1, 2018. The company serves a combined 228 residential customers near Oak Harbor on Whidbey Island in Island County. Crosswood's last rate increase was for \$7,600 (17.2 percent) and was effective January 1, 2016, and Shirona Water Company only recently became regulated, with 102 customers, on January 12, 2018, and has not had a previous rate case.

This filing would change both previous companies' tariffs to a single tariff rate for water services since they are both under common ownership and operations.

Customer Comments

On May 29, the company notified its customers by mail of the proposed rate increase. Customers were notified that they may access relevant documents about this rate increase on the commission's website, and that they may contact John Cupp at 1-888-333-9882 or

john.cupp@utc.wa.gov with questions or concerns. Staff received four consumer comments, all opposed to the increase.

General Comments

• Four comments came from customers on the Crosswoods system. They feel it is unfair that the increase to them is higher than the increase to customers on the Shirona water system.

Staff Response

Staff explained the potential benefits to customers when all systems' rates and expenses are blended.
