Status of Compliance of Companies Named in Notice of Intent to Cancel Certificate

Dear Mr. Johnson:

On October 16, 2018, the Commission served a Notice of Intent to Cancel Private, Non-Profit Transportation Provider Certificate and Opportunity to Request a Hearing (Notice) on nine private, non-profit companies that failed to file an annual safety report and/or pay the annual regulatory fee. The Notice stated that the Commission would cancel each company's certificate unless, within 30 days, the company (1) came into compliance with applicable law by submitting the delinquent annual safety report and paying the required regulatory fee or (2) requested a hearing to demonstrate why the company's certificate should not be canceled.

More than thirty days have now elapsed since service of the Notice. As of December 18, 2018, all nine companies have come into compliance. Because these companies are now in compliance the Commission need not cancel their certificates.
