DECLARATION OF JASON HOXIT

I, Jason Hoxit, under penalty of perjury under the laws of the state of Washington, declare as follows:

1. I am over 18 years of age and competent to testify to the facts contained herein.
2. I am employed by the Washington Utilities and Transportation Commission (Commission) as a compliance investigator in the Transportation Safety Division. As a compliance investigator, my responsibilities include conducting investigations into the operations of regulated and unregulated transportation companies. As part of those duties, I investigate charter party or excursion service carriers that may be operating without the required Commission-issued certificate.
3. I have reviewed Michael Dotson's investigation of Jumpin' Joey's LLC d/b/a Lymelight Party Bus (Jumpin' Joey's or Company) in its entirety and have reviewed other supporting documentation uploaded by Michael Dotson to the Motor Carrier Investigations database.
4. On October 1, 2020, Jumpin' Joey's posted an advertisement for a black Ford Econoline bus to its Facebook page.<sup>1</sup> The Company's post stated, "Now we have something for the grown-ups the [*sic*] party in."
5. On October 16, 2020, Jumpin' Joey's posted an advertisement for a white stretch Chevrolet Tahoe to its Facebook page.<sup>2</sup> The Company's post stated, "If you're a tree hugger and you love the environment we got you with a smooth sailing HYBRID. STRECH [*sic*] TAHOE."
6. On October 29, 2020, Michael Dotson uploaded an advertisement from Facebook Marketplace for party rentals, which was posted from Joey Bowers' Facebook account the week prior.<sup>3</sup> The advertisement included a picture of the interior of a party bus matching the Ford Econoline bus owned by Joey Bowers, listed a price of \$120, and the description

stated, “20 foot high movie screen bounce house slides party bus and more Party Rental stuff.”

7. On October 29, 2020, Michael Dotson uploaded screenshots of Washington Department of Licensing’s (DOL) DRIVES application for vehicle information on Joseph Michael Bowers (Joey Bowers), which produced records showing ownership of a black cutaway Ford Econoline with license plate number C87077U registered at the physical and mailing address of 37831 Auburn Enumclaw Road SE, Auburn, Washington, 98092; and showed ownership of a white Chevrolet Tahoe with license plate number BUB0358 registered at the physical and mailing address of 37831 Auburn Enumclaw Road SE, Auburn, Washington, 98092.<sup>4</sup>
8. On January 4, 2021, Joey Bowers posted a picture with a black Ford Econoline bus and a white stretch Chevrolet Tahoe with license plate number BUB0358 to Joey Bowers’ Facebook page.<sup>5</sup>
9. On January 6, 2021, Michael Dotson sent a compliance letter to Jumpin’ Joey’s at 37831 Auburn Enumclaw Rd. SE, Auburn, Washington, 98092.<sup>6</sup> The compliance letter stated that Commission staff (Staff) believed Jumpin’ Joey’s was engaging in passenger transportation services that required a Commission-issued certificate and required Joey Bowers to respond no later than January 17, 2021, to avoid enforcement action by the Commission.
10. On January 13, 2021, Michael Dotson spoke with Joey Bowers at telephone number (253) 315-5541. During the phone conversation, Mr. Dotson documented that Joey Bowers stated that Jumpin’ Joey’s started advertising too early thinking the COVID pandemic would have ended, stated Jumpin’ Joey’s would come into compliance when the charter and excursion industry re-opened, and explained that the pictures on Facebook were of family.<sup>7</sup>
11. On September 20, 2021, I received an email stating that Jumpin’ Joey’s transported a group of passengers to the Jason Aldean concert at the White River Amphitheater on September 17, 2021.<sup>8</sup> The email included a picture of a white stretch Chevrolet Tahoe with license plate number BUB0358 parked at the White River Amphitheater with people gathered around the vehicle.

12. On December 11, 2021, Jumpin' Joey's posted to its Facebook page a picture of a group in the party bus with the caption, "Family Night Watching Holiday Lights!"<sup>9</sup>
13. On December 22, 2021, the Company posted a picture of a different group in the party bus to its Facebook page with the caption, "Another Fun Ride To Spanaway Holiday Lights!"<sup>10</sup>
14. On January 15, 2022, Jumpin' Joey's posted to its Facebook page a picture of a group in the party bus with the caption, "Happy 11<sup>th</sup> Birthday Cruise Down Ruston Way with Quick Stop For Ice Cream!"<sup>11</sup>
15. On January 16, 2022, the Company posted a picture of a group in the party bus to its Facebook page with the caption, "Sunday Funday!"<sup>12</sup>
16. On January 19, 2022, Jumpin' Joey's posted a video of the interior of a party bus to its Facebook page with the caption, "Wood Floors, 2 Dance Poles, Wrap Around Leather Seats...The True Party Bus Added To Our Fleet!"<sup>13</sup> The interior of the bus in the video differed from the pictures of the party bus owned by Joey Bowers.
17. On January 22, 2022, the Company posted to its Facebook page pictures of a group in the party bus with the caption, "Good Times With Celebrity Cheer Unlimited Competition Day! Pulled Up To The Next Level Championships In Style!"<sup>14</sup>
18. On January 29, 2022, Jumpin' Joey's posted a picture of a group in the party bus to its Facebook page with the caption, "Happy 15<sup>th</sup> Birthday."<sup>15</sup>
19. On February 5, 2022, Jumpin' Joey's posted to its Facebook page a picture of a group in the party bus with the caption, "Dinner Date El Gauchos!"<sup>16</sup>
20. On February 21, 2022, the Company posted a picture of a group in the party bus to its Facebook page with the caption, "If you not talking money...you not making cents."<sup>17</sup>
21. On March 11, 2022, Jumpin' Joey's posted a picture of a group in the party bus to its Facebook page with the caption, "Nice Drive & Gorgeous Night at Alki."<sup>18</sup>

22. On March 26, 2022, the Company posted to its Facebook page a picture of a group in the party bus with the caption, “Happy Quinceañera.”<sup>19</sup>
23. On April 1, 2022, Jumpin’ Joey’s posted a giveaway for two free bouncy house rentals to its Facebook page. The Company’s post provided a link to its Instagram page, [instagram.com/jumpin\\_joey1](https://www.instagram.com/jumpin_joey1), and included the hashtag “#PartyBusRental.”<sup>20</sup>
24. On April 17, 2022, the Company posted a picture of a group in the party bus to its Facebook page with the caption, “Happy 18<sup>th</sup> Birthday Theo! Cruise Around Seattle & Dinner at Buca di Beppo.”<sup>21</sup>
25. On April 17, 2022, Jumpin’ Joey’s posted to its Facebook page a picture of Joey Bowers’ property at 37831 Auburn Enumclaw Road SE, Auburn, Washington, 98092, with two black buses parked in the background.<sup>22</sup> One the buses pictured has a license plate number of CAP1448, which is registered to Arthur Sanchez at the physical and mailing address of 480 Garland Place, Enumclaw, Washington, 98022.<sup>23</sup>
26. On April 30, 2022, Jumpin’ Joey’s posted to its Facebook page a reminder for its giveaway of two free bouncy house rentals and included the hashtag “#PartyBusRental.”<sup>24</sup>
27. On May 11, 2022, Michael Dotson contacted Jumpin’ Joey’s through its Facebook page and inquired if the Company could provide transportation for around 18 to 20 passengers in Seattle. Jumpin’ Joey’s responded, and suggested Mr. Dotson “Follow our party bus Instagram page Lymelight\_PartyBus” or text “Arthur” at phone number (253) 414-2662.<sup>25</sup>
28. On May 19, 2022, Michael Dotson visited the Company’s Instagram page at [www.instagram.com/lymelight\\_partybus](https://www.instagram.com/lymelight_partybus). On the Company’s Instagram front page, the Company used a picture of a black Ford Econoline bus with license plate number C87077U as its profile picture,<sup>26</sup> stated that it provides luxury transportation in the Seattle and Tacoma areas, and listed a price of \$175 per hour.<sup>27</sup>

29. On May 19, 2022, Michael Dotson visited the Company's Instagram photo page and observed pictures of a party bus in use,<sup>28</sup> with at least three pictures identical to pictures posted on Jumpin' Joey's Facebook page.<sup>29</sup> The Company has since removed the Instagram page located at [www.instagram.com/lymelight\\_partybus](http://www.instagram.com/lymelight_partybus).<sup>30</sup>
30. On May 19, 2022, Michael Dotson contacted the Company at (253) 414-2662 via text message using a proxy phone number and asked if the Company could provide transportation for 18-20 passengers from Tacoma to Seattle for five to six hours on June 17 or June 24. That same afternoon, the Company responded and suggested that the group try for a Saturday date and confirmed that the \$175 per hour price was accurate.<sup>31</sup>
31. On June 12, 2022, Jumpin' Joey's posted a picture of a group in the party bus to its Facebook page with the caption, "Happy Birthday!"<sup>32</sup>
32. On June 30, 2022, Michael Dotson searched Washington Department of Revenue's (DOR) Business Licensing Service for UBI number 604-891-355, which produced records showing that Jumpin' Joey's has an active business license. The record showed Joey Bowers as the governing person with a physical and mailing address of 37831 Auburn Enumclaw Road SE, Auburn, Washington, 98092.<sup>33</sup>
33. On July 19, 2022, Michael Dotson searched Commission records, which showed that Jumpin' Joey's did not have the required authority to provide charter party or excursion carrier service in the state of Washington.<sup>34</sup>
34. On September 28, 2022, I visited the Company's Instagram page at [www.instagram.com/jumpin\\_joey1](http://www.instagram.com/jumpin_joey1), and found that Jumpin' Joey's is following the Instagram account, [lymelight\\_ent](http://www.instagram.com/lymelight_ent).<sup>35</sup>
35. On September 28, 2022, I visited the Company's Instagram page at [www.instagram.com/lymelight\\_ent](http://www.instagram.com/lymelight_ent).<sup>36</sup> On the Instagram page, the Company used a picture of

a black Ford Econoline bus with license plate number C87077U as its profile picture<sup>37</sup> and posted at least 11 pictures that are identical to pictures used on Jumpin' Joey's Facebook page.<sup>38</sup>

36. On October 7, 2022, I searched DOR's Business Licensing Service for any business with the name "Lymelight," which did not produce any records for Lymelight Party Bus.<sup>39</sup>
37. Based on paragraphs 4 through 36 above, Staff finds that Jumpin' Joey's operated as a charter party or excursion service carrier in the state of Washington without first obtaining the required certificate from the Commission.

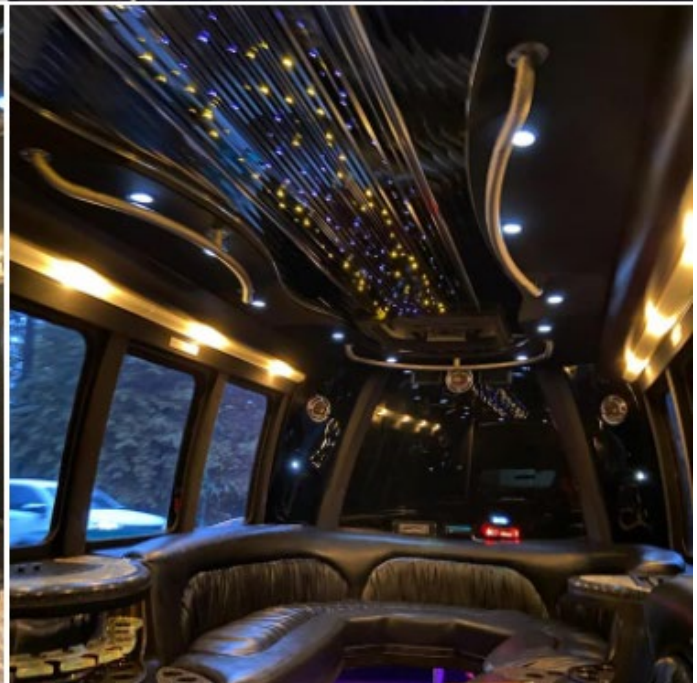

Second Notice**

Dear Joey Bowers:

The Washington Utilities and Transportation Commission (Commission) believes that you are providing passenger transportation services that require charter and excursion authority from the Commission. The purpose of this letter is to learn more about the passenger transportation services your company offers and to provide technical assistance with respect to Washington's passenger transportation licensing requirements.

As defined in WAC 480-30-036, one or more of the vehicles advertised and operated by your company requires a charter and excursion certificate from the Commission. Any company that operates a "vehicle with a manufacturer's seating capacity for eight or more passengers, including the driver, used on the public highways, for the transportation of persons for compensation", requires a charter and excursion certificate from the Commission.

Commission records show that you have not obtained the **required** certificate to operate as a charter and excursion carrier. Providing these services without a certificate is illegal, considered a gross misdemeanor, and punishable as defined in RCW 81.70.220 and WAC 480-30-246. Each violation of RCW 81.70.220 is subject to a penalty of up to \$5,000 per violation.

**To avoid enforcement action by the Commission, no later than January 17, 2021, please do one of the following:**

- Submit a completed application, file proof of insurance, and include the application fee to the Commission. For questions about the application process, please contact our Licensing Services staff at (360) 664-1222
