Commission Staff's Response to Request for Payment Arrangement

Dear Mr Killip:

On October 7, 2024, the Washington Utilities and Transportation Commission (Commission) issued a penalty assessment against My Brothers Moving and Transportation LLC d/b/a My Brothers Moving, (My Brothers Moving or Company) in the amount of \$8,400 for violations of Washington Administrative Code (WAC) 480-15-555, Criminal Background Checks for Prospective Employees; WAC 480-15-560, Vehicle and Driver Safety Requirements, which adopts Title 49 Code of Federal Regulations (49 C.F.R.) Part 391 – Qualifications of Drivers and Part 396 – Inspection, Repair and Maintenance.

On October 21, 2024, the Company submitted its application for mitigation of the penalties.

On October 29, 2024, the Commission entered Order 01, which reduced the penalty to \$4,350 and suspended a \$2,000 portion of the penalty for a period of two years before being waived, subject to conditions. Order 01 required the Company to pay the \$2,350 portion of the penalty that is not suspended within 10 days or enter into a mutually agreeable payment arrangement with Staff.

On October 30, 2024, Commission staff (Staff) and My Brothers Moving came to a mutual agreement on a proposed payment plan, as follows:

Staff recommends the Commission grant the Company's request for payment arrangements. My Brothers Moving is aware that if it fails to pay any installment by the due date, the entire remaining balance, including the suspended penalty, will immediately become due and payable without further Commission order.
