RE: DO NOT REDOCKET—Docket UE-220359 Addendum to PacifiCorp's Washington State Transportation Electrification Plan

PacifiCorp dba Pacific Power & Light Company (PacifiCorp) submitted its first Washington Transportation Electrification (TE) Plan, in accordance with RCW 80.28.365, on May 20, 2022. The Company has continued to engage with Commission Staff, customers, stakeholders, and industry partners to further refine its approach to addressing the rapidly evolving transportation electrification sector. That work has resulted in some refinement to the plan as originally submitted. This addendum is intended to clarify the following items:

- Provide an updated forecast in light of new policy shifts;
- Add in targets and goals associated with proposed programs;
- Highlight a more comprehensive reporting schedule;
- Discuss and clarify distribution system impacts; and
- Provide new language regrading interoperability standards as it relates to future programming.

In addition, PacifiCorp is including a series of workpapers to allow stakeholders an opportunity to review the analysis completed to support development of the Washington TE Plan.

- WA Portfolio Budget. Breakdown of assumed WA costs for the portfolio budget over the next five years.
- File Map. Index of the tables and figures that have been updated in light of the new forecast.
- WA TE Plan Updated Tables & Figures. Included in this excel file is the updated tables and figures integrated the new forecast completed.
