SPECIAL SURCHARGE SUPPLEMENT NO. 2

Applies on Carrier's Tariff No. 19

The Commission approves a temporary surcharge of \$1.51 per month on the monthly recycling collection rate reflected in Item 100 as a result of the additional costs associated with the closure of CRC recycling processing facility during its construction by the company during the months of March, April, and May 2023, to be collected from customers as a separate line item on the billing, as follows:
