Should the Washington Utilities and Transportation Commission (Commission) approve our request, customers will experience a rate decrease throughout most classes of service.

As you may be aware, it has been nearly six years since our last general rate case. In that time, Basin Disposal, Inc. has experienced significant increases in costs that are essential to delivering services, including, insurance, fuel, maintenance expenses, along with federal and state employment taxes. In addition, the company continues to acquire new assets to ensure it can deliver the safest, most efficient and reliable service possible. If approved, the proposed rates will become effective on June 1, 2023.

The proposed rate decrease for our Residential services ranges from approximately -1.27% to 0%, and not all offered services are listed above. If you have questions about the proposed rate decreases, you may contact the company at (509) 547-2476.

The Commission has the authority to set final rates that may be either lower or higher than the company's request, depending on the results of its investigation.
