The purpose of this letter is to act in accordance with the recommendation on pages 64 and 65 of the prefiled rebuttal testimony of John H. Story, Exhibit No. JHS-14T in consolidated Docket Nos. UE-090704 and UG-090705. The referenced section of testimony recommends that the PCA Exhibits be recalculated by the Company based on the final Commission order and to file the pages with the compliance filing. Due to complexities resulting from the creation of Schedule 133 – Regulatory Asset Rider, it was not possible to have the PCA Exhibits recalculated in time for the compliance filing that was made on April 6, 2010.

A copy of this letter has been served on each party to this proceeding.
