MEMORANDUM

- 1 NATURE OF PROCEEDING: Docket TR-070696 involves a petition by BNSF Railway Company, formerly known as Burlington Northern Santa Fe Railway Company (BNSF) to abandon and close to public use a railroad-highway grade crossing located at Hickox Road, Mount Vernon, Skagit County, WA (US DOT #084737D) in accordance with Revised Code of Washington (RCW) 81.53.060.
- 2 MOTION FOR EXTENSION OF TIME: On October 8, 2007, BNSF Railway Company filed a motion for a one-week continuance to October 15, 2007, to file prefiled testimony of Dan MacDonald. BNSF stated that they anticipated receiving Mr. MacDonald's testimony on October 8, but learned later that day that Mr. MacDonald went out of town on business and was unable to get it to BNSF in time to file. BNSF further states the Mr. MacDonald's testimony is important to BNSF's case, for which the continuance is requested.
- BNSF demonstrates good cause for the request under WAC 480-07-385(3)(c)¹ for a late-filed request for continuance. The company was not aware of the need for a continuance until the due date for filing testimony, and requested an extension on that day. Further, ranting the extension will not cause a change in the overall procedural

schedule. In addition, BNSF states that it does not oppose an extension of time for all parties to file testimony responsive to Mr. MacDonald's testimony.

4 THE COMMISSION ORDERS That the BNSF Railway Company's request for an extension of time to file the prefiled testimony of Dan MacDonald to October 15, 2007, is granted.
