Re: Comments opposing PSE and Energy Eastside plan to erect an 18-mile transmission line through Bellevue and other Eastside cities.

To the Utilities and Transportation Commission,

I am firmly opposed to Puget Sound Energy's plan to build additional high voltage transmission lines through Bellevue and surrounding neighborhoods. I stand with CENSE, 350 Eastside and thousands of other residents who believe these lines are an unnecessary part of an antiquated plan that makes no effort to analyze current power trends and renewable alternatives, instead relies solely on outdated studies selectively chosen only for their own financial benefit. We need a greener, cleaner plan that takes into account new technology geared towards providing power WITHOUT doing harm to the environment and our surrounding communities.

Bellevue has propped itself up as a future forward city claiming that it is building for "tomorrow", but this plan is straight out of the 1980's. Electricity consumption is trending downwards over the last 6 years, as both commercial and residential consumers have become more energy efficient in both technology and practice. Alternative power transmission and storage options are on the rise, including batteries that can (and should) be used for peak load capacity storage.
