I, Kristin Jacobson, declare as follows:

I make this declaration based upon personal knowledge of the matters stated herein. I am over the age of 18 and am competent to testify.

- 1 I am the Counsel, Regulatory Affairs, West Region for Sprint Nextel Corporation ("Sprint Nextel"). I am responsible for regulatory affairs in Sprint Nextel's Western Region, comprised of ten states. I am listed as the regulatory contact for Sprint Communications Company on the Commission's list of competitive local exchange companies that appears on the Commission's website. Sprint Nextel Corporation's registered CLEC in Washington is Sprint Communications Company.
- 2 To the extent that Sprint Nextel inadvertently named the parent corporation of Sprint Communications Company, Sprint Nextel Corporation, in its late-filed petition to intervene, we have asked to amend our late-filed intervention to include its registered CLEC, Sprint Communications Company.

3 I did not receive the Notice of Prehearing Conference with a service date of May 17, 2010. Attached hereto is true and correct copy of the service list used for the Notice of Prehearing Conference that was provided to us by the Commission Records Center on June 22, 2010. It indicates that no written notice was sent to me or anyone else from Sprint.

4 On June 21, 2010, I spoke with Mr. Steven Elliott of the Records Center at the Commission. Mr. Elliott confirmed that the Commission is not currently set up to automatically electronically notify all potentially interested parties (in this case, all telecommunications providers operating in the State of Washington) when a new filing of this nature is received. Accordingly, I did not receive the Notice of Prehearing Conference electronically, or otherwise.


5 I live and work primarily in California. I was not aware of any media coverage regarding any filing for merger approval by Qwest or CenturyLink in the state of Washington.

6 While I have been trying to track the Qwest/CenturyLink proceedings in the various states that I am responsible for this ability has been hampered recently by my medical condition. I have been under medical treatment for various medical issues since May 1, 2010, with repeated doctors' appointments, culminating in the need for surgical procedures, the first of which I underwent on June 15, 2010.

7 I first became aware of this proceeding on June 8, 2010 when I contacted Mr. Mark Vasconi of the Commission staff, as well as the Records Center, in an attempt to ascertain whether Qwest or CenturyTel had yet filed a merger related petition. It was during these conversations that I learned that the petition had been filed and that the Pre-hearing Conference had occurred 7 days earlier. Once I was aware of this proceeding, I promptly prepared the petition to intervene which was filed on June 11, 2010.

8 I declare under penalty of perjury under the laws of the United States of America and the
State of California that the foregoing testimony is true and correct.
