On April 3, 2002 Qwest filed its Supplemental Response to AT&T's Statement of Supplemental Authority Regarding Qwest's Performance Assurance Plan, which included as an attachment thereto the Stipulation between the Utah Advocacy Staff and Qwest Regarding Performance Assurance Plan. Following that filing and in response to CLEC comments, Qwest and Advocacy Staff agreed to make some additional changes to the stipulated language. Qwest submits for this Commission's consideration and deliberation of the QPAP issues, Qwest's comments (Attachment 1) and an indication of how the changes would be incorporated into the Stipulated language previously filed with the Commission (Attachment 2). Qwest also notes that, subsequent to this Commission's briefing and oral arguments, Qwest offered to include a new section which is shown in Attachment 2, in bold, to facilitate the use of any agreements between Qwest and CLECs arising from any Regional Oversight Committee (ROC) PID
