On May 28, 2002, the Washington Utilities and Transportation Commission (Commission) filed with the Code Reviser a Preproposal Statement of Inquiry (CR-101) to initiate a rulemaking to consider revisions to chapters 480-30 and 480-40 WAC. The companies affected by this rulemaking include auto transportation companies (those motor carriers providing service over regular routes or between fixed termini), passenger charter carriers, and passenger excursion carriers.

ISSUES PAPER

Commission Staff has drafted a Rulemaking Issues Paper to present stakeholders with a series of issues and proposals for discussion at the initial workshop scheduled for September 12, 2002. No rule drafting will be done until stakeholders have had an opportunity to comment.
