Objectionable passengers: This company reserves the right to refuse to transport persons under the influence of drugs or alcohol, or who are incapable of taking care of themselves, or whose conduct or behavior may be objectionable to other passengers. No passenger shall create any disturbance or unnecessary noise to distract the driver. All passengers are required to wear a seat belt. No eating or drinking while in the vehicles. No smoking allowed in the vehicles.

Schedule maintenance: Carrier will not be liable for delays caused by accidents, breakdowns, bad conditions of roads, snow storms or other conditions beyond the control of the carrier and does not guarantee arrival at, or departure from, any point at any specific time.

Ticket redemption: Door-to-door reservation service only, no-prepaid fares, payment is due upon the completion of the trip. Customers who fail to show up by the scheduled departure time of their reservation at the designated pick-up point or who have not cancelled or changed their reservation at least 24 hours prior to that time are not eligible for a refund and will be charged \$1.50 per mile from point to point.
