4	JUDGE TOREM: Good afternoon. Let's be on
5	the record. It's Wednesday afternoon, a little after 1:30,
6	April 23, 2014. This is Docket UT-121986.
7	We're here in this docket today in Olympia,
8	Washington, because on March 19, 2014, the Washington
9	Utilities and Transportation Commission issued a complaint
10	against Qwest Corporation, d/b/a CenturyLink QC and Qwest
11	Communications Company LLC d/b/a CenturyLink QCC.
12	This complaint alleges violations of RCW
13	80.36.130 and WAC 480-120-461. And it seeks a specific
14	dollar amount, \$313,070 in penalties be imposed against
15	respondent Qwest and CenturyLink. That was served March 19.
16	And we got word from the Company they did not
17	wish to file an answer.
18	So the Commission sent out a prehearing
19	conference notice March 28 of this year and scheduled this
20	proceeding.
21	My name is Adam Torem. I'm the
22	Administrative Law Judge presiding over this case.
23	We'll take appearances from the parties.

And we've already discussed most of the

procedural requirements off the record, and we'll just make

- 1 them part of the record today.
- 2 First for Commission Staff?
- 3 MR. FASSIO: Mike Fassio, Assistant Attorney
- 4 General on behalf of Commission Staff.
- I did file and serve a notice of appearance,
- 6 and I would be happy to summarize my contact information if
- 7 it's necessary.
- JUDGE TOREM: I don't think so.
- 9 For the Company?
- 10 MS. ANDERL: For the Company, Lisa Anderl,
- inhouse counsel representing the Respondents in this case.
- 12 And I've verified that the Notice of
- 13 Prehearing Conference today contained my accurate contact
- 14 information.
- JUDGE TOREM: Okay. And you also have
- 16 someone from the company with you today you wanted to
- 17 introduce for the record and add to the e-mail service
- 18 list?
- 19 MS. ANDERL: Yes, please, your Honor. To my
- 20 left is Phil Grate. He's public policy director and has
- 21 responsibilities for Washington. And if you'll put him on
- 22 the e-mail list for service.
- JUDGE TOREM: Okay. Can I ask for the
- 24 spelling of your last name?
- MR. GRATE: G-R-A-T-E.

- JUDGE TOREM: Okay. Thank you, Mr. Grate.
- 2 There's nobody on the bridge line because we
- 3 did not reserve it for today. So there's nobody else in the
- 4 room that appears they wish to intervene in the case.
- 5 Mr. Fassio, are you aware of anyone else that
- 6 wanted to intervene?
- 7 MR. FASSIO: I am not.
- 8 JUDGE TOREM: And Ms. Anderl, you haven't
- 9 heard of any potential intervenors?
- MS. ANDERL: I've heard nothing.
- JUDGE TOREM: All right. I'll make a note of
- 12 that.
- 13 You said discovery rules would be applicable
- 14 to this case, and you thought prefiled testimony would be
- 15 exchanged in sequence. So it sounds as though data requests
- 16 and the discovery rules will be applicable. So we'll
- 17 authorize discovery.
- 18 There was also a discussion as to whether any
- 19 of the prefiled testimony might contain customer
- 20 information, which typically, if it's provided to the
- 21 Commission, might not be private or confidential anymore.
- 22 But if the company records aren't exactly the papers that
- 23 are submitted by the customers, there would still be a
- 24 concern to make sure no privacy violations occurred. So for
- 25 that issue, I will issue the standard protective order,

- 1 making sure if there's anything else that comes in that's
- 2 outside the bounds of it, you let me know if you need to
- 3 otherwise expand the protective order. But I'll enter the
- 4 protective order that's our standard language for the
- 5 Commission.
- 6 Mr. Fassio, I'm going to have you recite the
- 7 proposed schedule on how to handle this complaint against
- 8 CenturyLink and get all the evidence in to the Commission in
- 9 the months ahead.
- 10 MR. FASSIO: Thank you, your Honor.
- 11 We have agreed on a proposed schedule. And
- 12 the dates are as follows: The first date is for Staff to
- 13 file its prefiled direct testimony and exhibits on June 26,
- 14 2014.
- The second date is the Company filing its
- 16 prefiled response testimony and exhibits on August 7, 2014.
- 17 Staff would file its rebuttal testimony on
- 18 September 10, 2014.
- 19 And then we would schedule a hearing on a
- 20 hearing date of October 7, 2014, if that date is available.
- 21 JUDGE TOREM: All right. And I think subject
- 22 to confirmation, my calendar shows it available. And I
- 23 think you've already checked with ALD staff.
- 24 Ms. Anderl, do those dates line up with what
- 25 you talked to Mr. Fassio about?

- 1 MS. ANDERL: Yes, exactly. Thank you.
- 2 JUDGE TOREM: My understanding is also that
- 3 the parties will engage in settlement negotiations, but
- 4 we're not going to specify a particular date so that you're
- 5 not handcuffed to any one particular date prior to the
- 6 filing of testimony or even ongoing after that filing.
- 7 If you do reach a settlement prior to any of
- 8 these dates coming up where you need the procedural schedule
- 9 suspended or extended to allow further settlement
- 10 discussions, you have to let me know. Otherwise, that June
- 11 26 date will be the first triggering date of papers being
- 12 filed in the case.
- 13 Anything else we need to take care of
- 14 procedurally in this matter from the Commission's
- 15 perspective?
- 16 MS. ANDERL: Your Honor, I'm sorry. I didn't
- 17 ask you this off the record. But are there any dates that
- 18 you were unavailable that you know of if we have discovery
- 19 disputes or if we do have any motions or anything that we
- 20 want to file?
- 21 Sometimes it's good to know if the ALJ is not
- 22 going to be right at his desk.
- JUDGE TOREM: As of today, I know for sure
- 24 I'm out of town next week and then a week in July. I think
- 25 it's somewhere between the Staff direct and the CenturyLink

- 1 response. I think it's July 19 to 27.
- 2 MS. ANDERL: Okay. Thanks. Sorry to put you
- 3 on the spot.
- 4 JUDGE TOREM: No worries.
- 5 MS. ANDERL: Thank you.
- 6 JUDGE TOREM: There may be another chunk of
- 7 time, but that still remains up in the air. But right now
- 8 those are the weeks that I know: One here bridging April
- 9 and May and one in mid-July.
- 10 So any other items that we have to address
- 11 and put into the prehearing conference order?
- MS. ANDERL: Not for CenturyLink, your Honor.
- MR. FASSIO: Not for Staff, your Honor.
- JUDGE TOREM: All right. Thank you for your
- 15 advance work getting the schedule together.
- 16 And all those dates look clear, particularly
- 17 the hearing date from where I can see it on my calendar.
- 18 I'll confirm that.
- 19 We can figure out the number of copies that
- 20 have to be filed, and I'll put that into the prehearing
- 21 conference order. That should come out by the end of week.
- 22 And I'll wait to hear if there's a
- 23 breakthrough in settlement discussions between now and June
- 24 26. And if so, we'll schedule the appropriate hearing or
- 25 get the right pleadings in to have the settlement reviewed
