NOTICE OF TELEPHONIC
PREHEARING CONFERENCE
(Set for July 13, at 1:30 p.m.)

- 1 **APPLICATION:** On March 24, 2020, ADE Dumpsters, LLC, (ADE or Applicant) filed with the Washington Utilities and Transportation Commission (Commission) an application for authority to operate as a solid waste collection company in Washington (Application), and on April 6, 2020, the Commission issued a notice of pending application, allowing affected parties 30 days to protest the Application.
- 2 **PROTEST.** On April 27, 2020, Murrey’s Disposal Company, Inc., and Harold LeMay Enterprises, Inc., filed a protest to the Application. On May 4, 2020, Rabanco Ltd., d/b/a Emerald City Disposal, Tri-County Disposal, Lynnwood Disposal, Eastside Disposal, Rabanco Companies, Sea-Tac Disposal, Rabanco Connections, Republic Services, and Rabanco Recycling; and Waste Management of Washington, Inc., d/b/a Waste Management – North Sound, Waste Management – Marysville, Waste – South Sound, and Waste Management of Seattle, also filed protests.
- 3 **STATUTORY AUTHORITY:** The Commission has jurisdiction over this matter under RCW Title 80 and RCW Title 81, and has legal authority to regulate solid waste collection companies in the state of Washington. The statutes that apply to this matter include RCW 80.01, RCW 80.04, and RCW 81.77, including but not limited to RCW 80.01.040, RCW 80.04.020, RCW 81.77.020 and RCW 81.77.040. The rules that apply to this matter include those within Washington Administrative Code (WAC) 480-07 and 480-70, relating to solid waste collection companies.
- 4 **PROCEDURES:** The Commission will hear this matter under the Administrative Procedure Act (APA), particularly Part IV of RCW 34.05 relating to adjudications. The provisions of the APA that relate to this proceeding include, but are not limited to RCW 34.05.413, RCW 34.05.422, RCW 34.05.431, RCW 34.05.440, RCW 34.05.449, and RCW 34.05.452. The Commission will also follow its procedural rules in WAC 480-07 in this proceeding.

- 5 The Commission finds there is good cause to hear this matter on shortened notice. *See* WAC 480-07-440(1)(a) and RCW 34.05.434.
- 6 **THE COMMISSION GIVES NOTICE That it will hold a telephonic prehearing conference in this matter at 1:30 p.m. on July 13, 2020. - 7 **PURPOSE:** The purpose of the prehearing conference is to consider requests for intervention, to resolve scheduling matters including establishing dates for distributing evidence, to identify the issues in the proceeding, and to determine other matters to assist the Commission in resolving the matter, as listed in WAC 480-07-430. The Commission will set the time and place for the evidentiary hearings at the prehearing conference or by later written notice.
- 8 **INTERVENTION:** Persons seeking to intervene in the proceeding must file written petitions to intervene at least three business days before the date of the prehearing conference. *See* WAC 480-07-355(a).
- 9 **NOTICE OF APPEARANCE; INTERPRETER:** Party representatives must file notices of appearance with the Commission, as required by WAC 480-07-345(2), no later than the day before the conference. If any party needs an interpreter or other assistance, they should fill out the form attached to this notice and return it to the Commission.
- 10 **THE COMMISSION GIVES NOTICE that any party who fails to attend or participate in the prehearing conference set by this Notice, or any other stage of this proceeding, may be held in default under RCW 34.05.440 and WAC 480-07-450.**
