NOTICE OF BRIEF ADJUDICATIVE PROCEEDING (Set for Wednesday, April 26, 2023, at 1:30 p.m.)

RE: In re Application of Accurate NW Moves LLC for a Permit to Operate as a Motor Carrier of Household Goods, Docket TV-230083

TO ALL PARTIES:

On July 1, 2022, Accurate NW Moves LLC (Accurate NW or Company) filed with the Washington Utilities and Transportation Commission (Commission) an application for authority to operate as a household goods carrier in the state of Washington (Application).

On February 17, 2023, the Commission issued a Notice of Intent to Deny Application (Notice) that also provided a notice of opportunity to request a hearing to contest the factual allegations set out in the Notice.

On February 20, 2023, Accurate NW requested a hearing, which the Commission noticed as a Brief Adjudicative Proceeding (BAP) set for March 29, 2023.

On March 27, 2023, Accurate NW contacted the Commission, requesting that the matter be rescheduled to allow the Company time to seek counsel.

On March 28, 2023, the Commission issued a Notice Converting Brief Adjudicative Proceeding to Prehearing Conference (PHC Notice), which converted the scheduled BAP to a prehearing conference (PHC).

On March 29, 2023, the Commission convened a PHC in this matter, during which the presiding officer granted Accurate NW's request for a continuance to allow the Company time to seek the

advice of counsel. The presiding officer set a deadline of April 14, 2023, for the Company to respond with potential hearing dates.

On April 10, 2023, the Company contacted the Commission by email and requested to schedule a BAP.

Parties wishing to submit any other documents for consideration at the BAP must file with the Commission a list enumerating and describing any such documents **no later than 5 p.m. on Thursday, April 20, 2023**. Parties must also email such documents to the presiding officer also by 5 p.m. on Thursday, April 20, 2023.

THE COMMISSION GIVES NOTICE That it will conduct a brief adjudicative proceeding in Docket TV-230083 beginning at 1:30 p.m. on Wednesday, April 26, 2023.
