Amendment No. 25 adds terms and conditions for Voice over Internet Protocol ("VOIP") as set forth in Attachment 1 to this amendment, attached hereto and incorporated herein by this reference.

This amendment amends the interconnection agreement first approved by the Commission on April 30, 1997 in WUTC Docket No. UT-960356 (current docket number) between Qwest Corporation and XO Communications Services, Inc.

By virtue of Company B's signature on the amendment, Company A believes that Company B agrees with these representations.
